

RESOLUTION NO. 2026-08-____(R)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH GARVER, LLC FOR DESIGN AND RELATED PROFESSIONAL SERVICES FOR PHASE II AND PHASE III OF THE MCKINNEY NATIONAL AIRPORT TAXIWAY C PROJECT (AI2721 & AI2722), CONTINGENT UPON RECEIPT OF FAA AIRPORT IMPROVEMENT PROGRAM GRANT FUNDING; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, the City Council of the City of McKinney, Texas, desires to make certain improvements to the McKinney National Airport; and

WHEREAS, the City of McKinney has accomplished a formal RFQ selection process in which Garver, LLC was selected to serve as the Airport’s Engineer of Record; and

WHEREAS, the City Council of the City of McKinney, Texas, desires to complete Phase II and Phase III of the Taxiway C project (AI2721 & AI2722); and

WHEREAS, the City has prepared a contract with Garver, LLC to complete the design of Phase II and Phase III of the Taxiway C Project (AI2721 & AI2722).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. The foregoing recitals are hereby found to be true and correct legislative and factual findings of the City of McKinney, Texas, and are fully incorporated into the body of this Resolution.
- Section 2. The City Manager is hereby authorized to execute a design contract in the amount of \$3,040,000.00 with Garver, LLC for Phase II and Phase III of the McKinney National Airport Taxiway C project (AI2721 & AI2722), contingent upon receipt of the allocated FAA Airport Infrastructure Grant funding.
- Section 2. The City Manager is hereby appointed and authorized to execute on behalf of the City of McKinney, at the appropriate time, and with the appropriate authorizations of this governing body, all contracts and agreements with Garver, LLC, and such other parties as shall be necessary and appropriate for the implementation of the improvements to the McKinney National Airport.
- Section 3. This resolution shall take effect immediately from and after the date of passage and is so resolved.
