

RE: Apex Center elevator addition



Ms. Jackson,

We are pleased to submit this Consulting Services Agreement for the above project. Our approach is to provide services on a combination of fixed fee (design) and hourly basis (construction administration).

Project Description:

- A. **Design Scope of Work** Design of a new service elevator on the north side of the building, based on a traction elevator selection selected by the city and manufactured and installed by Otis Elevator Company. Elevator will have 3 stops, one at each level of the existing building. Refer to attached Figure 1 for plan concept
 - 1) **BSW**: Architectural & interior design and coordination to integrate the new elevator with existing building envelope. Elevator specifications and shop drawings shall be provided by Otis in order to design the shaft.
 - 2) **Structural Design**: Engineering design and documentation for foundation and framing for new elevator shaft and coordination of addition with existing structure. Assumes use of original project soils report recommendations.
 - 3) **MEP Engineering**: Mechanical, electrical and plumbing engineering design and documentation for accommodating new elevator addition.

B. Construction Administration ("CA"):

1) Provide standard CA services on an as-needed basis. This would include review of submittals, RFIs & pay applications. May also include issuing of any necessary revisions and creation of a punch list.

Assumptions:

- 1.) Bidding is assumed to by City through job order delivery method. BSW assistance during bidding phase includes issuing addenda, responding to bidder RFIs, and in evaluating bids.
- 2.) Construction will be let through standard City or AIA contracting terms and General Conditions.
- 3.) Accessibility plan review and inspection will be performed by City vendor.
- 4.) Fire alarm and protection design will be via performance specification.

Exclusions:

- 1.) Detailed estimating services.
- 2.) Commissioning services.
- 3.) As-built record documents (available as additional services).
- 4.) Payment of permitting fees.

Schedule:

A. BSW shall develop a schedule in concert with City, Otis, and prospective contractor as feasible for all parties and any constraints presented by ongoing operations at site.
