JULY 22, 2025

The City Council of the City of McKinney, Texas met in special session and work session in the City Hall Council Chambers, 401 E. Virginia Street, McKinney, Texas, on Tuesday, July 22, 2025, at 4:00 p.m.

Mayor Bill Cox called the meeting to order at 4:02 p.m. upon determining a quorum consisting of himself and the following McKinney City Councilmembers were present: Mayor Pro Tem Geré Feltus and Councilmembers Patrick Cloutier, Rick Franklin, Michael Jones, Justin Beller, and Ernest Lynch.

CHAPTER III. - THE CITY COUNCIL

Sec. 8. - Number of council members.

The City Council shall be composed of a Mayor and six (6) Council Members, who shall be elected in the manner set forth in this Charter. The Mayor and City Council Members shall take office upon canvassing following the date of election, and their terms of office shall begin as of that date. They shall serve until their respective successors shall have been elected and shall have qualified, except as otherwise provided for herein.

Sec. 9. - Council election.

There shall be held in the City of McKinney on the uniform election date in May 2013, and every four (4) years thereafter, or on such date or dates as may be prescribed by the laws of the State of Texas, a City election for a Mayor, a Council Member-at-large 1, a Council Member representing District 1, and a Council Member representing District 3. Any current office holder's term shall be extended according to law until the uniform election date in May 2013 and thereafter until their successors are elected and qualified.

There shall be held in the City of McKinney on the uniform election date in May 2015, and every four (4) years thereafter, or on such other date or dates as may be prescribed by the laws of the State of Texas, a City election for a Council Member-at-large 2, a Council Member representing District 2, and a Council Member representing District 4. Any current office holder's term shall be extended according to law until the uniform election date in May 2015 and thereafter until their successors are elected and qualified.


CHAPTER III. - THE CITY COUNCIL

Sec. 10. - Council districts.

The City of McKinney shall be divided into four (4) Council districts, and a Council Member shall be elected by the resident voters of each district. Each Council Member representing a Council district must at the time of his or her election and during the term of office physically reside with legal domicile, in the district which they represent. For purposes of this Section and the Charter, "physically reside" shall mean (i) the candidate or Council Member must use their residence address for voter registration and driver's license purposes, and (ii) the candidate or Council Member shall provide to the City Secretary proof whereby such person uses their residence address as the person's home address on documents such as employment records, government forms and loan applications, and (iii) the candidate or Council Member must not claim a homestead exemption on any property other than the residence. The four (4) Council districts shall be defined by ordinance, and the boundaries thereof shall be subject to review by the Council to ensure equal voting rights for all citizens under state and federal law. Council district boundaries shall be redefined by ordinance to compensate for any significant change in population within a given district.



Current City Council Districts – 4 Single Member Districts



McKinney Council District Options

Six Single Member Districts

Pros:

- Makes it more likely that issues unique to a specific area will have a voice on the council.
- Easier to campaign in a single district than At-Large
- Easier to be elected in a single member district than At-Large
- Potentially reduced litigation risk under the Voting Rights Act

Cons:

- Only have input into the election of one council member
- Concerns over district-centric representation
- Requires re-drawing districts and adjustment to new system

More council seats

- Smaller districts easier to get elected
- Added costs
- Can maintain At-Large seats so constituents can vote for more than one council member.

Election of All Council Members

Texas Local Government Code § 21.006

- Added by Acts 2023, 88th Leg., ch. 1124 (H.B. 3613), § 1, eff. Sept. 1, 2023.
 - Municipality divided into SMDs
 - shall elect "all members of the municipality's governing body following each apportionment."
 - Next uniform election that allows time to comply with all legal requirements.
 - If staggered terms, Council adopts an equitable process to determine which member serve shorter terms to accommodate election after apportionment to address:
 - The remaining time in each member's term
 - Whether a member's term was previously shortened by this Section

H.B. 5431 - Failed in the 89th Session

•Would have exempted at large council members and the Mayor from the election requirement:

A municipality that elects one or more members of its governing body at-large, including the office of mayor, is not required to hold an election for those positions following apportionment unless the term of office of the at-large member or mayor would otherwise expire under applicable law.

Timing for Charter Election

- First uniform election after council orders election or qualifying citizen
 petition or earlier of the next municipal general election or presidential
 election.
 - Must be at least 30 days after ordinance calling election and allow for time to comply with other requirements of law.
 - Two years after last charter election
- Proposition could be scheduled to take effect at a future date, for example to coincide with redistricting after the 2030 census (i.e. May 2032 election).
 - Election requirement may be modified or eliminated in the interim.
- Address staggering of terms as part of charter election?
- Possible scenario: two (2) Charter Elections: May 2027 (non-District propositions) and May 2029 (District Composition propositions)



Redistricting One Person - One Vote

- U.S. Constitution single-member districts must have approximately equal populations
- Rule of thumb: total deviation < 10%
 - Compare most populous and least populous districts to "ideal"-sized district
- Add both departures from ideal together

Calculating the Overall Deviation



Highest Positive Percent + Highest Negative Percent = Maximum Deviation

[(Total Population – Ideal Size) / Ideal Size] * 100]
