**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY,
TEXAS, AUTHORIZING THE 2010-2014 COMMUNITY DEVELOPMENT
BLOCK GRANT CONSOLIDATED PLAN AND 2010-2011 ANNUAL
ACTION PLAN, AND PROVIDING AN EFFECTIVE DATE**

WHEREAS, the City Council of the City of McKinney, Texas, authorizes the City Manager to make application for Community Development Block Grant Funds (CDBG); and

WHEREAS, the Community Grants Advisory Commission has held three public meetings and prepared recommendations for Council acceptance of the 2010-2011 Annual Action Plan and the 2010-2014 Consolidated Plan for the use of Community Development Block Grant Funds; and

WHEREAS, the U.S. Department of Housing and Urban Development will review and accept the 2010-2014 Consolidated Plan and Annual Action Plan providing CDBG funds for the 2010-2011 fiscal year on October 1, 2010.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby adopts the 2010-2014 Community Development Block Grant Consolidated Plan with the Strategic Plan portion of the Consolidated Plan, to be followed for the next five years, and the City Council of the City of McKinney, Texas hereby adopts the 2010-2011 Annual Action Plan with funding allocations as follows:
