

CITY COUNCIL REGULAR MEETING

JANUARY 20, 2026

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 401 E. Virginia Street, McKinney, Texas, on Tuesday, January 20, 2026 at 6:00 p.m.

Mayor Bill Cox called the meeting to order at 6:08 p.m. upon determining a quorum consisting of himself and the following City Councilmembers were present: Mayor Pro Tem Geré Feltus and Councilmembers Justin Beller, Patrick Cloutier, Rick Franklin, Michael Jones, and Ernest Lynch.

City Manager Grimes invited members of the public to volunteer for the annual PIT count; the Parks & Recreation Department will be hosting a hiring fair on Saturday, February 7 and Saturday, March 7; he along with Assistant City Manager Minyard attended the Martin Luther King Jr parade in Plano and noted McKinney will be hosting the parade for the next 2 years; and he recognized Indiana University on their National Championship win.

Council unanimously approved the motion by Mayor Pro Tem Feltus, seconded by Councilmember Beller, to adjourn the meeting at 6:35 p.m.
