**26-0036Z** Conduct a Public Hearing to Consider/Discuss/Act on a Request to Rezone the Subject Property from "PD" - Planned Development District to "C3" - Regional Commercial District, Located on the East Side of Grassmere Lane and Approximately 180 Feet North of West University Drive (REQUEST TO BE TABLED)

Jacob Bennett, Planner II for the City of McKinney, presented the item and informed the Commission of a notification sign posting error on behalf of the applicant. Chair Woodard opened the public hearing and called for comments. There were none.
