My name is Jayson K Bates, and I am a resident of McKinney. I am writing to express my strong opposition to the proposed mosque at 5321 Virginia Parkway. I am deeply concerned about the compatibility of this project with our community. Author and historian William J. Federer, in his well-researched book What Every American Needs to Know About the Qur'an: A History of Islam & the United States, documents 1,400 years

of Islamic history, including patterns of conquest, political expansion, and the integration of religious, political, and military authority under Sharia. Federer's work, along with many other historical sources, shows that Islam has often sought dominance rather than simple coexistence in non-Muslim societies. Given this documented history and the stated doctrines in Islamic texts regarding supremacy over other faiths, placing a mosque in a predominantly Christian neighborhood raises serious questions about long-term cultural and religious transformation. Residents have legitimate fears based on real-world examples elsewhere. I urge the City Council to:

Prioritize the preservation of our community's character, values, and safety

Represent the concerns of current McKinney residents over religious expansion that conflicts with American norms

My political concern is practical and local. A mosque is almost never just a quiet place of worship. It quickly becomes a gathering point that draws additional families who often bring different expectations about the relationship between religion and civil authority.

Once that concentration forms, it starts to shape school-board decisions, curriculum pressures, local elections, and the

unwritten rules of the neighborhood. Over time the original community's working assumptions about free speech, equal treatment under one set of laws, and the limits of religious authority in public life can be steadily diluted. I have seen this pattern unfold in other places, and I do not want it for the streets where my children play and the schools they attend. I am not interested in policing anyone's private faith. I am interested in preserving a political culture in which every citizen, including my daughters, can expect the same neutral legal protections rather than gradual pressure to accommodate a competing set of rules. That is a judgment about the future of my community, not a judgment about any single person.

Under municipal and state regulations, the City Council has the authority to enforce rigid public safety and engineering conditions. request that the City deny this site plan or withhold approval until the developer legally binds themselves to the following rigorous infrastructural upgrades:

Subsurface Stormwater Detention Mandate: Due to the massive impervious acreage and building square footage proposed, standard open drainage basins pose immediate structural, pest, and aesthetic risks to our borders. I demand that the City Engineer strictly enforce the Storm Water Ordinance by requiring a fully enclosed, below-grade structural concrete retention vault system to handle all site runoff internally.

Comprehensive Off-Site Infrastructure Fees: The vehicular volume generated by a multi-building campus will severely degrade local collector streets. I demand that final site plan approval be conditioned on the developer fully funding a dedicated deceleration turn lane on Virginia Parkway, a synchronized intersection traffic signal system, and complete pavement remediation of South Crutcher Crossing to heavy weight

I am writing to oppose the McKinney Islamic Association's proposed Islamic center at the southeast corner of Virginia Parkway and Crutcher Crossing.

Crutcher Crossing is one of only two entrances to the Stone Brook Crossing neighborhood. Recent developments have already increased traffic and congestion on Virginia Parkway and local streets. A 32,500–37,000 square foot facility on 5 acres will generate substantial additional vehicle trips, particularly during Friday prayers, Eid, and Ramadan events. This will exacerbate existing congestion and create safety risks.

The project's scale appears incompatible with the surrounding residential area. I request a comprehensive traffic impact analysis using current Virginia Parkway data, detailed parking calculations to prevent street spillover, and confirmation of adequate stormwater management and emergency vehicle access.

The specific location and size raise legitimate concerns about neighborhood character, public safety, and infrastructure capacity. Cumulative impacts from other approved developments in the area must also be considered.

I ask the City Council to require full independent studies and deny or significantly modify the application at the August 4, 2026 meeting.

Subsurface Stormwater Detention Mandate: Due to the massive impervious acreage and building square footage proposed, standard open drainage basins pose immediate structural, pest, and aesthetic risks to our borders. I demand that the City Engineer strictly enforce the Storm Water Ordinance by requiring a fully enclosed, below-grade structural concrete retention vault system to handle all site runoff internally.

Comprehensive Off-Site Infrastructure Fees: The vehicular volume generated by a multi-building campus will severely degrade local collector streets. I demand that final site plan approval be conditioned on the developer fully funding a dedicated deceleration turn lane on Virginia Parkway, a synchronized intersection traffic signal system, and complete pavement remediation of South Crutcher Crossing to heavy industrial weight capacities.

Maximum Perimeter Screening and Structural Buffering: To satisfy Section 206C structural screening requirements, standard commercial fencing is entirely inadequate to insulate the Brookview 1 and Stone Brook Crossing 1 subdivisions. I demand a continuous 10-foot-tall reinforced ashlar stone masonry wall paired with a mandatory 30-foot-deep landscape buffer zone packed exclusively with fully mature, 4-inch caliper evergreen canopy trees.
