The Board unanimously approved the motion by Board member Petkovsek, seconded Board member Kennedy, to approve the request, with a vote of 6-0-0.

Rayna Alam, Historic Preservation Planner I for the city of McKinney, presented the application. The Board asked questions which were addressed by staff. Mark McReynolds, Applicant, 218 University Avenue, Waxahachie, TX, explained the request and answered questions. Board Member Petkovsek motioned to approve item HP2025-0028 without conditions, seconded by Board Member Kennedy, to approve the request with a vote of 3-3-0. Motion failed for lack of majority vote. Vice-Chairperson Escamilla, Board Member Burris and Alternate Board Member Prior-Roberston voted against the motion.

Council Member Geré Feltus addressed the Board. The Board unanimously approved the motion by Vice-Chairperson Escamilla, seconded by Alternate Board Member Prior-Roberston, to table to the item to the July 03, 2025 meeting, with a vote of 6-0-0.

Chairperson Pence called for board and staff comments.
