

Organization Description / Executive Summary

Ratrodtober, now in its 7th year, is a premiere rat rod, hot rod, classic car and vintage motorcycle show in McKinney, TX. Voted one of the top festivals by D Magazine, Ratrodtober brings car enthusiasts from all over the country to McKinney for a weekend of vintage cars, live music, entertainment, and fellowship. The show, held at TUPPS Brewery, has garnered national attention, having been featured in Rat Rod Magazine and countless other publications. The show has been recognized as in the "Top 3" largest rat rod car shows in the country. Our goal is to turn Ratrodtober into a flagship event for McKinney – driving tourism for the city and local businesses.

Each year, Ratrodtober selects a charitable organization to be the beneficiary of proceeds raised through raffles and other fundraising activities. The beneficiary for 2023 is Warriors Keep, a 501(C)(3) tax exempt non-profit organization whose mission is to unite, empower and enhance the quality of life for veterans with the use of Outdoor Therapy. Outdoor therapy has been shown to improve quality of life and allow veterans the opportunity to process and reflect on their experiences in a positive environment.

Entertainment is a big component of the show. We book live music and other family friendly activities to augment participants' engagement. This year's bands include BC and the Big Rig, LuLu and the Black Sheep. These bands stand alone in their talent and will bring a large following to the show.

We plan to create and can a custom Ratrodtober beer to be sold at the event. The can design, which will feature elements of the show and the brewery, could also feature downtown McKinney's water tower and/or other landmarks that make McKinney unique.

A fan favorite of the show is the "Freak Out the Square Cruise In". This rat rod only ride-in will start at a sponsor location in McKinney where a light breakfast is provided. Rat rods ride through McKinney's Downtown Historical District and arrive at TUPPS Brewery just as the event is kicking off! The ride is approximately 3-5 miles and begins around 9:20am. In the past, we've had people come out of their homes and out of the restaurants of downtown McKinney to watch these unique and eye-catching vehicles pass by.

The event continues to grow, with each year increasing in registered vehicles and audience attendance. The show is family friendly. Expected attendance, based on previous years, is between 5,000 – 7,000.





The main purpose of these financial documents is to show that it is an established company in McKinney.

Regarding the timeline, the grant can be used for the advertisement and promotion of the event and if you contract the ad buys way in advance as it is intended and you confirmed below, we should be good.

Event signage or day-of entertainment and/or logistics are a little bit trickier and I will let Aaron respond to that as the grant is not really intended for it.

2.) <u>Timeline:</u>

I saw that your event Ratrodtober Car & Bike Show takes place on October 13 and 14, 2023.

I want to avoid any surprises further down the road and therefore I want to highlight, that outlined in our grand guidelines on the bottom of page 4 it states:

"All approved Advertising & Promotional grants must be completed as provided in the performance agreement. <u>All funds must be distributed by Sept. 30</u> of the fiscal year in which the grant was awarded unless prior consent is secured from Visit McKinney by Aug. 30 of that same fiscal year."

Since our Fiscal Year runs October 1 through September 30th, we need all re-imbursement requests for the grant buttoned up the very lasted beginning of August/mid-August to allow time to write reimbursement checks before 9-30-2023. Re-imbursement can take up to 30 days.
