## RESOLUTION NO. 2025-06-\_\_\_ (MUTD)

A RESOLUTION OF THE MCKINNEY URBAN TRANSIT DISTRICT BOARD AUTHORIZING THE CITY MANAGER TO SEEK AN EXTENSION OF THE INTERLOCAL AGREEMENT BETWEEN DALLAS AREA RAPID TRANSIT LOCAL GOVERNMENT CORPORATION AND THE CITY OF MCKINNEY FOR ONE ADDITIONAL ONE-YEAR RENEWAL TERM; AND AUTHORIZE STAFF TO TAKE NECESSARY ACTION TO IMPLEMENT PROGRAM UPDATES

- WHEREAS, the City of McKinney ("City") previously entered into an interlocal agreement with Dallas Area Rapid Transit Local Government Corporation the "LGC") on behalf of the McKinney Urban Transit District ("MUTD"); and
- WHEREAS, the LGC was organized for the purpose of acting on behalf of Dallas Area Rapid Transit ("DART") in the performance of its governmental functions of providing a public transportation system by contract to provide public transportation services outside the DART Service Area; and
- WHEREAS, the interlocal agreement between the City and LGC (the "ILA") was for an "Initial Term" that expired on December 31, 2024; and
- WHEREAS, the ILA between the City and LGC provides for extensions of up to two (2) additional successive one-year terms upon the mutual agreement of all parties; and
- WHEREAS, the MUTD Board requested and approved an extension of the ILA for one (1) additional successive one (1) year term from January 1, 2025, until December 31, 2025 (the "Renewal Term"), with which request for a Renewal Term LGC agreed; and
- WHEREAS, the ILA requires the City to inform LGC no less than six (6) months (180 days) prior to termination of the Renewal Term that the MUTD would like to extend the ILA for a second one-year Renewal Term; and
- WHEREAS, the ILA requires LGC and the DART Board to consider the approval of the requested extension and notify City no less than 60 days after receipt of MUTD's request where LGC and the DART Board will agree to extend the ILA; and
- **WHEREAS,** there is a continuing need for public transportation services within the communities participating in the MUTD; and
- **WHEREAS**, there is a need for continuity in transit operations to ensure adequate transit service and maintain quality of life in our community.

## NOW, THEREFORE, BE RESOLVED BY THE MCKINNEY URBAN TRANSIT DISTRICT BOARD, THAT:

- Section 1. The foregoing provisions are hereby found to be true and correct and are hereby incorporated herein by reference for all purposes allowed by law.
- Section 2. Staff is hereby authorized to seek an extension of the ILA for a second one-year Renewal Term from January 1, 2026 until December 31, 2026 with DART LGC under the variable fare structure previously adopted by the MUTD.
- Section 3. Staff is hereby further authorized to carry out MUTD Board-approved program updates to ensure continuing fiscal sustainability.

Section 4. This Resolution shall take effect immediately from and after its passage and it is so duly resolved.
