CITY COUNCIL REGULAR MEETING

JANUARY 21, 2025

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, January 21, 2025 at 6:00 p.m.

- WHEREAS, Mr. Greg Conley has been a Public Safety servant of the North Texas area since 1988, beginning his career in the city of Mesquite before moving on to the city of Garland in 1992, working in a wide variety of divisions and rising to the rank of Assistant Chief in 2000; and
- WHEREAS, Mr. Conley became our Chief of Police in 2015, stepping up to address unprecedented challenges within the city, working to enhance safety measures, and helping to strengthen our collective sense of a unified community; and
- WHEREAS, upon arrival, Chief Conley was soon responsible for peacefully navigating the aftermath of the "Pool Party" incident, which placed McKinney in the national media spotlight; and
- WHEREAS, he created the Chief's Advisory Council that is still utilized by his successor Chief Joe Ellenburg; and he created and staffed the Intelligence Unit, the Case Management, the Neighborhood Police Officer Unit, and the Community Services Unit, all of which operate to better serve responsiveness, accessibility, and engagement for the safety needs of all McKinney residents; and
- WHEREAS, after retiring as Police Chief in 2022, Conley was named the city's first Director of Public Safety, providing executive support to the Police, Fire, and Emergency Management departments; and
- WHEREAS, a man of faith with an educational background in Theology as well as Criminology & Criminal Justice, Mr. Conley leads with distinguishment, care and compassion for all he serves, whether they be McKinney law enforcement professionals or the residents of our city; and
- WHEREAS, the City of McKinney organization and residents are beneficiaries of the service of Greg Conley, whose strong influence will positively impact us all far into the future, it is appropriate to thank him for his efforts and contributions to establishing McKinney, Texas, and one of the nation's safest cities in which to live, work, play, and visit.


CCN Decertification

- City established Extraterritorial Jurisdiction and Certificate of Convenience and Necessity (CCN) to guide development for the City and establish boundaries for providing Water and Wastewater Services.
- Changes in recent State legislation created development conditions in the ETJ that are unpredictable.
- October 9, 2023 McKinney petitioned the PUC to decertify portions of its CCN

Temporary Cessation Ordinance

- June 25, 2024 City adopts Temporary Cessation Ordinance on any new water and wastewater connections (amended and restated in December 2024)
- Purpose is to limit water service expansion until PUC case is concluded.
- Ordinance is valid through July 1, 2025.



Section 7. Exemptions, A

1. Ongoing Projects. The temporary cessation enacted by this ordinance does not apply to any project or property which has received any plan or permit approval from the City prior to the effective date of this Ordinance.

Applicant Evidence for "Ongoing Projects" and Analysis

- 1. <u>Utility Verification Letter</u> (8/21/23) The utility letter identifies the types and sizes of utilities in the general area where the Property is situated.
- 2. Conveyance Plat (12/6/2023) The utility plat is labeled "NOT FOR DEVELOPMENT." A Conveyance Plat is for the purpose of sale or conveyance.
- 3. TXDOT Driveway Permit (1/17/2024) This is not a City permit.

Staff Recommendation: Denial of exception application.
