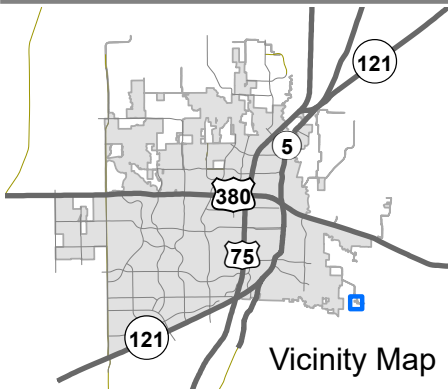
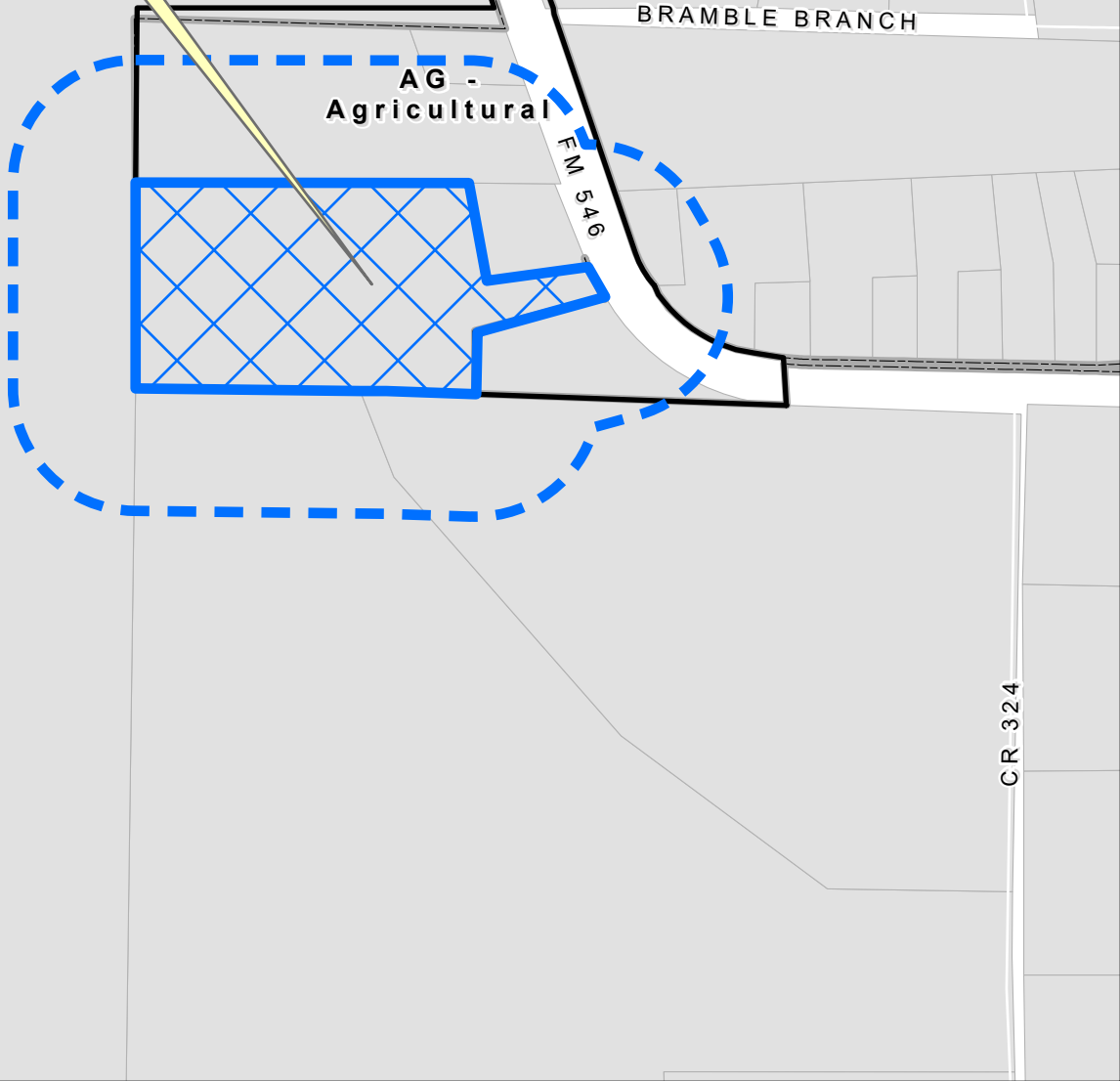
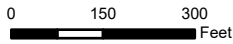

EXHIBIT B

Description and Depiction of Property

BEING situated in Collin County, Texas, a part of the R.H. Locke Survey, Abstract No. 517, and being a part of a 39.28 acre tract as described in a deed from Edd Hopes to Roy J. Wilson, dated April 12, 1941 and recorded in Volume 332, Page 103 of the Collin County Deed Records and being more particularly described by metes and bounds as follows:

BEGINNING at a corner post in the Southwest corner of the said tract;

THENCE South 89 degrees 36 minutes 17 seconds East with an established fence along the South line of said tract, a distance of 419.4 feet to a post;

THENCE South 88 degrees 10 minutes East with an established fence along the South line of said tract, a distance of 148.2 feet to a stake;

THENCE North a distance of 105.0 feet to a stake;

THENCE North 75 degrees 47 minutes East, a distance of 222.0 feet to an iron stake in the West right of way line of F.M. # 546;

THENCE North 26 degrees 26 minutes West with said Right of Way a distance of 57.7 feet to a concrete marker;

THENCE North 20 degrees 26 minutes West, a distance of 149.1 feet to an iron pipe;

THENCE North 89 degrees 56 minutes West with an established fence line, a distance of 705.0 feet to an iron stake in the West line of the said tract;

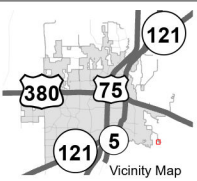
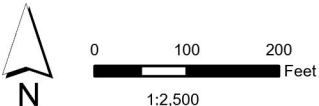
