A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A SUPPLEMENTAL AGREEMENT WITH LJA ENGEERING, INC. (LJA) FOR PROFESSIONAL ARCHITECTURAL AND ENGINEERING SERVICES FOR THE MCKINNEY LIGHT WALK AT TOWNE LAKE PARK PROJECT FOR AN INCREASE IN THE NOT TO EXCEED FEE FROM \$96,500 TO A TOTAL AGGREGATE CONTRACT AMOUNT, INCLUSIVE OF ANY ADDITIONAL SUPPLEMENTAL AGREEMENTS, NOT TO EXCEED \$118,875

WHEREAS, the City Council of the City of McKinney, Texas, recognizes the need for additional construction administration services for the McKinney Light Walk at Towne Lake Park Project; and,

WHEREAS, the City Council approved the budget on September 3, 2024; and,

WHEREAS, the City has received a proposal from LJA Engineering, Inc. to provide additional design services for the McKinney Light Walk at Towne Lake Park Project (PK4393), located at 1401 Wilson Creek Pkwy.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Manager is hereby authorized to execute a supplemental agreement with LJA Engineering, Inc. to provide additional professional architectural and engineering services for the design of the McKinney Light Walk at Towne Lake Park Project (PK4393) for an increase in the not to exceed fee from \$96,500 to a total aggregate contract amount, inclusive of any additional supplemental agreements, not to exceed \$118,875.
- Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
