- MEDC Staff Annual Evaluations MEDC staff annual evaluations were completed. The position of the Administrative Assistant is in the process of being upgraded to the Executive Assistant based on the job functions and work load.
- Economic Development Coordinator MEDC new position, Economic Development Coordinator, was posted for two weeks and was closed on October 12. The position was posted through the City of McKinney website and on industry related websites. Ninety-four applicants met the minimum requirements. Human Resource staff has been instrumental during the process. Staff is in the process of reviewing the applications.
- MEDC Office Space MEDC conference room will be converted into two cubicles, one for the new Economic Development Coordinator and the other for future use. Staff has been working with the approved vendors from Purchasing to review the layout and pricing proposals.
