The Planning and Zoning Commission, along with Steve Wilson, met under its authority as the City of McKinney Capital Improvements Advisory Committee per resolution No. 95-02-11 (R) as amended by Resolution No. 2019-06-074 (R) in the Council Chambers, 401 E. Virginia Street, McKinney, Texas, on Tuesday, May 27, 2024, at 5:30 p.m.
