

ORDINANCE NO. 2026-05-XXX

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AMENDING THE ZONING MAP OF THE CITY OF MCKINNEY, TEXAS; SO THAT AN APPROXIMATELY 10.5 ACRE PROPERTY, LOCATED APPROXIMATELY 260 FEET NORTH OF U.S. HIGHWAY 380 (UNIVERSITY DRIVE) AND APPROXIMATELY 610 FEET EAST OF NORTH LAKE FOREST DRIVE, IS REZONED FROM "PD" PLANNED DEVELOPMENT DISTRICT TO "PD" PLANNED DEVELOPMENT DISTRICT, "MF36" – MULTI-FAMILY RESIDENTIAL DISTRICT, AND "R5" – RESIDENTIAL DISTRICT, GENERALLY TO ALLOW FOR MULTI-FAMILY RESIDENTIAL, SINGLE FAMILY RESIDENTIAL, AND COMMERCIAL USES AND MODIFY THE DEVELOPMENT STANDARDS; PROVIDING FOR SEVERABILITY; PROVIDING FOR INJUNCTIVE RELIEF, PROVIDING FOR NO VESTED INTEREST; PROVIDING FOR THE PUBLICATION OF THE CAPTION OF THIS ORDINANCE; PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, the City of McKinney has considered the rezoning of an approximately 10.5 acre property, located Approximately 260 Feet North of U.S. Highway 380 (University Drive) and Approximately 610 Feet East of North Lake Forest Drive, which is more fully depicted on Exhibits "A", "B", "C" and "D" attached hereto, from "PD" – Planned Development to "PD" Planned Development District, "MF36" – Multi-Family Residential, and "R5" – Residential District, generally to allow for Multi-family Residential, Single Family Residential, and Commercial uses and modify the Development Standards; and,

WHEREAS, after due notice of the requested rezoning as required by law, and the required public hearings held before the Planning and Zoning Commission and the City Council of the City of McKinney, Texas, the City Council is of the opinion that the change in zoning district should be made.

NOW THEREFORE BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS:

Section 1. The zoning map is hereby amended so that an approximately 10.5 acre property, located approximately 260 Feet North of U.S. Highway 380 (University Drive) and approximately 610 Feet East of North Lake Forest Drive, which is more fully depicted on Exhibits "A", "B", "C" and "D" attached hereto, from "PD" – Planned Development to "PD" Planned Development District, "MF36" – Multi-Family Residential, and "R5" – Residential District, generally to allow for Multi-family Residential, Single Family Residential, and Commercial uses and modify the Development Standards; and.

Section 2. The subject property shall develop in accordance with Section 204X, 204L, and 204H of the Unified Development Code ("PD" Planned Development, "MF36" – Multi-family Residential, and R5" – Residential District) of the Zoning Ordinance, and as amended, except at follows:

1. The subject property rezoned "PD" – Planned Development District shall develop in accordance with attached Development Regulations – Exhibit "D".

Section 3. If any section, subsection, paragraph, sentence, phrase or clause of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and to this end, the provisions of this Ordinance are declared to be severable.

Section 4. It shall be unlawful for any person, firm or corporation to develop this property, or any portion thereof, in any manner other than is authorized by this Ordinance, and upon conviction therefore, shall be fined any sum not exceeding \$2,000.00, and each day that such violation shall continue shall be considered a separate offense. These penal provisions shall not prevent an action on behalf of the City of McKinney to enjoin any violation or threatened violation of the terms of this Ordinance, or an action for mandatory injunction to remove any previous violation hereof.

Section 5. That no developer or property owner shall acquire any vested interest in this Ordinance or specific regulations contained herein. The ordinance, and the subsequent site plans (if any) and regulations may be amended or repealed by the City Council of the City of McKinney, Texas, in the manner provided by law.

Section 6. The caption of this Ordinance shall be published one time in a newspaper having general circulation in the City of McKinney, and shall become effective upon such publication.
