

**RESOLUTION NO. 2025-08-\_\_\_\_**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO REQUEST AND ENTER INTO A GRANT AGREEMENT WITH THE RECYCLING PARTNERSHIP, INC., TO INCREASE ACCESS TO AND PARTICIPATION IN RESIDENTIAL RECYCLING PROGRAMS AND TO DECREASE RESIDUAL CONTAMINATION; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS,** the City Council of the City of McKinney, Texas, has identified a need and is committed to increasing access to and participation in recycling programs, while reducing residual contamination in the City's recycling stream; and

**WHEREAS,** the City's 20-Year Solid Waste Management Strategy, adopted by the City Council in August 2022, informs City staff and leadership of residents' recycling habits, barriers to participation, and educational needs related to recycling and solid waste management; and

**WHEREAS,** in February 2024, the City received \$986,000 in grant funding from The Recycling Partnership, Inc. to support the purchase of residential recycling carts and to fund educational and outreach efforts; and

**WHEREAS,** the City is requesting up to \$778,000 in additional grant funding from The Recycling Partnership, Inc. to support the purchase of smart truck cameras designed to detect recycling contamination, as well as to fund related education and outreach efforts, and to conduct a pre- and post-implementation study; and

**WHEREAS,** during the grant period, the City shall provide The Recycling Partnership, Inc. with access to available annual recycling collection and processing data as an in-kind service;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The City Council of the City of McKinney, Texas, hereby authorizes the City Manager to request and accept grant funding in an amount up to \$778,000 from The Recycling Partnership, Inc., to support the purchase of smart truck cameras designed to detect recycling contamination, as well as to fund related education and outreach efforts and to conduct a pre- and post-implementation study.

Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
