**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A SUPPLEMENTAL AGREEMENT WITH GRANTHAM & ASSOCIATES, INC. FOR ADDITIONAL CONSULTING ENGINEERING SERVICES FOR THE COLLEGE, HUNT, DAVIS & CHURCH STREET INFRASTRUCTURE IMPROVEMENTS PROJECT FOR AN INCREASE IN THE NOT TO EXCEED FEE FROM \$790,000 TO A TOTAL AGGREGATE CONTRACT AMOUNT, INCLUSIVE OF ANY ADDITIONAL SUPPLEMENTAL AGREEMENTS, NOT TO EXCEED \$900,000**

**WHEREAS**, the City Council of the City of McKinney, Texas, recognizes the need for the additional consulting engineering services for the College, Hunt, Davis & Church Street Infrastructure Improvements Project (CIP Projects ST2222, DR2222, WA2222, and WW2222); and

**WHEREAS**, the City has received a proposal from Grantham & Associates, Inc. to provide additional consulting engineering services for the College, Hunt, Davis & Church Street Infrastructure Improvements Project (CIP Projects ST2222, DR2222, WA2222, and WW2222).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The City Manager is hereby authorized to execute a supplemental agreement with Grantham & Associates, Inc. to provide additional consulting engineering services for the College, Hunt, Davis & Church Street Infrastructure Improvements Project (CIP Projects ST2222, DR2222, WA2222, and WW2222) for an increase in the not to exceed fee from \$790,000 to a total aggregate contract amount, inclusive of any additional supplemental agreements, not to exceed \$900,000.

Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
