

ORDINANCE NO. 2024-06-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING A CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2023-2024 BUDGET AND THE 2024-2028 CAPITAL IMPROVEMENTS PROGRAM FOR ARCHITECTURAL AND ENGINEERING SERVICES FOR THE ROY AND HELEN HALL REIMAGINE PROJECT (PROJECT LI2441); AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2023-2024 Annual Budget and the Fiscal Year 2024–2028 Capital Improvements Program and submitted same to the City Council for its approval and a true and correct copy is attached.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2023-2024 Annual Budget and the 2024-2028 Capital Improvements Program is hereby authorized and approved.
- Section 2. The budget shall be amended by appropriating \$1,202,940 from the Library Construction Fund balance to the Capital Improvement Program for architectural and engineering services for the Roy and Helen Hall Reimagine Project (Project LI2441).
- Section 3. This Ordinance shall become effective from and after its adoption and is so ordained.
