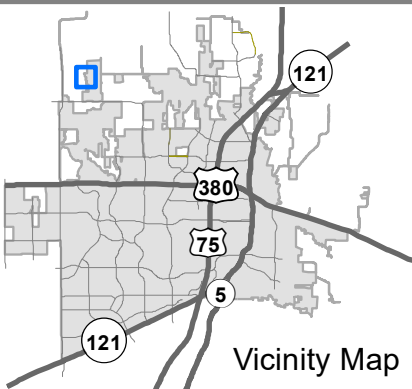
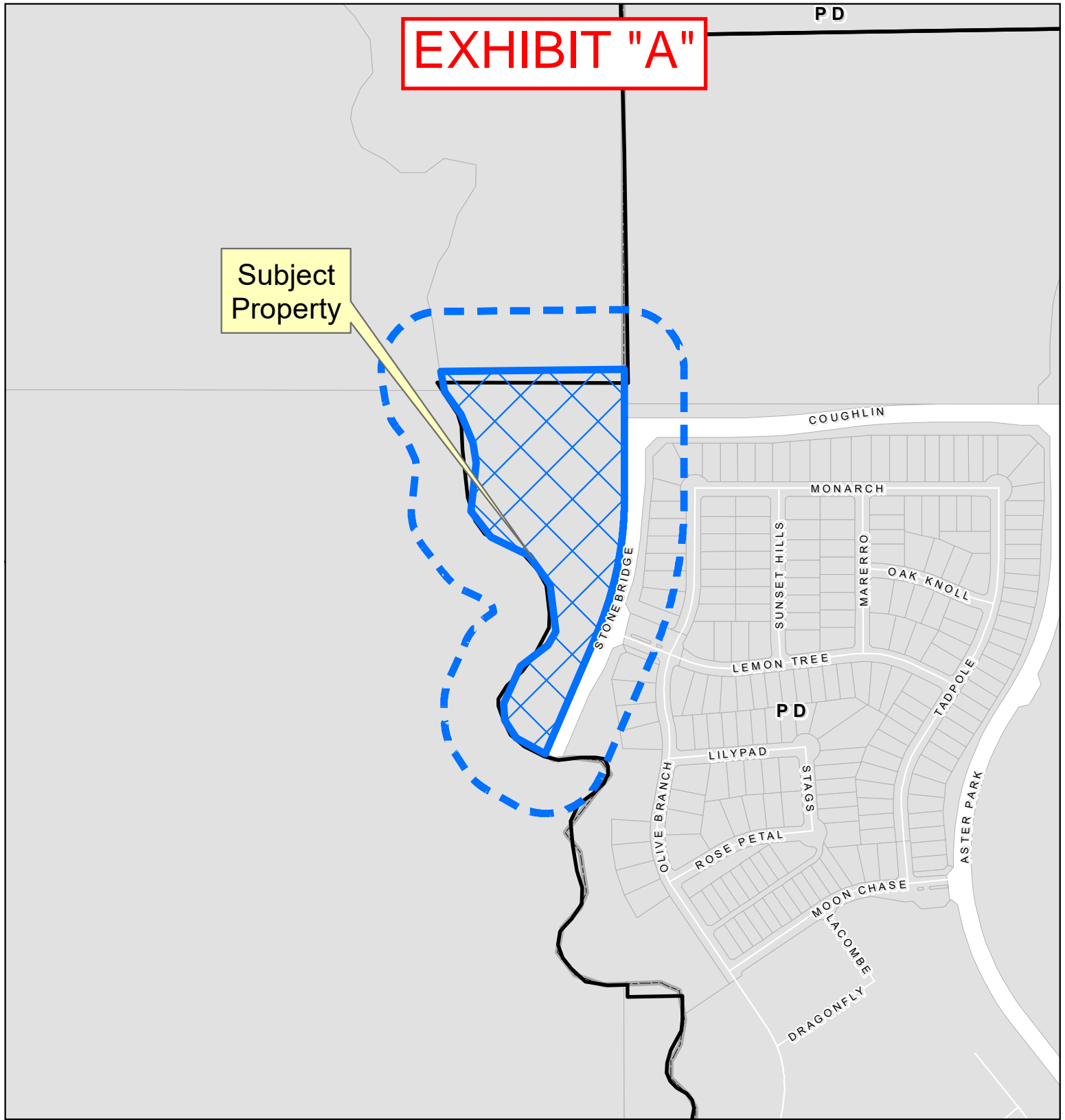


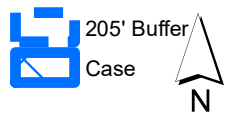

ZONE2025-0075

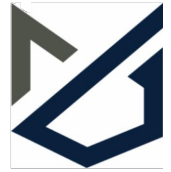

## LEGAL DESCRIPTION FOR ASTER PARK, PHASES 7 & 8 COMMERCIAL TRACT

All that certain lot, tract, or parcel of land, situated in a portion of the Charles A. Burns Survey, Abstract No. 109, City of McKinney, Collin County, Texas, being part of that certain called 428.025 acre tract described as Tract 1A in a deed to Spur Aster Park Land, L.P. recorded in Instrument No. 2025000039018 of the Deed Records of Collin County, Texas (DRCCT), and being more completely described as follows, to-wit:

**BEGINNING** at a 1/2" capped iron rod set stamped "GMCIVIL", hereinafter referred to as a 1/2" capped iron rod set, for the Northwest corner of Aster Park, Phase 1B1, a subdivision situated in the City of McKinney recorded in Book 2024, Page 673 of the Plat Records of Collin County, Texas (PRDCT)

**THENCE** South 00 deg. 05 min. 00 sec. East along the West right-of-way line of North Stonebridge Drive (variable width right-of-way dedication) as shown per said Aster Park, Phase 1B1, a distance of 275.45 feet to a 1/2" capped iron rod set for a Point of Curvature of a circular curve to the right, having a radius of 1,200.00 feet, a central angle of 23 deg. 24 min. 18 sec., and being subtended by a chord which bears South 11 deg. 37 min. 09 sec. West - 486.79 feet;

**THENCE** in a southerly direction along said West right-of-way line and curve to the right, a distance of 490.19 feet to a 1/2" capped iron rod set;

**THENCE** South 23 deg. 19 min. 18 sec. West tangent to said curve and continue along said West right-of-way line, a distance of 440.80 feet to a point in the West line of said 428.025 acre tract and the centerline of Stover Creek;

**THENCE** in a northerly direction along said West line and centerline the following fifteen (15) courses:

North 61 deg. 10 min. 01 sec. West, a distance of 114.29 feet;

North 33 deg. 14 min. 34 sec. West, a distance of 73.30 feet;

North 02 deg. 44 min. 35 sec. West, a distance of 56.73 feet;

North 24 deg. 05 min. 40 sec. East, a distance of 139.66 feet;

North 52 deg. 45 min. 55 sec. East, a distance of 119.55 feet;



North 30 deg. 01 min. 37 sec. East, a distance of 55.89 feet;

North 07 deg. 27 min. 05 sec. West, a distance of 162.48 feet;

North 35 deg. 47 min. 31 sec. West, a distance of 123.31 feet;

North 64 deg. 19 min. 28 sec. West, a distance of 144.71 feet;

North 37 deg. 16 min. 59 sec. West, a distance of 112.72 feet;

North 06 deg. 04 min. 32 sec. East, a distance of 165.18 feet;

North 09 deg. 04 min. 40 sec. West, a distance of 69.24 feet;

North 22 deg. 59 min. 28 sec. West, a distance of 108.98 feet;

North 36 deg. 05 min. 33 sec. West, a distance of 95.51 feet;

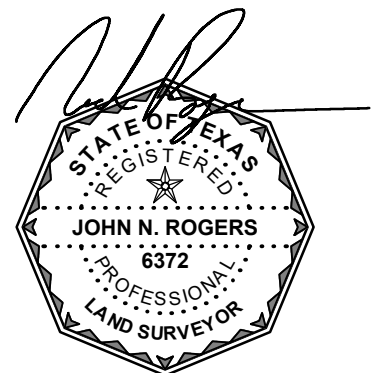
North 10 deg. 09 min. 16 sec. West, a distance of 71.19 feet to the most westerly Northwest corner of said 428.025 acre tract and being in the South line of a called 63.200 acre tract described in a deed to VSS Limited Partnership recorded in Volume 4070, Page 1092 (DRCCT);

**THENCE** North 89 deg. 23 min. 20 sec. East along said South line and a North line of said 428.025 acre tract, a distance of 631.52 feet to a 16" Hackberry Tree for an ell corner of said 428.025 acre tract and the Southeast corner of said 63.200 acre tract;

**THENCE** South 00 deg. 05 min. 00 sec. East departing said deed lines, a distance of 164.71 feet to the **POINT OF BEGINNING**, containing 463,053 square feet or 10.630 acres of land, more or less.

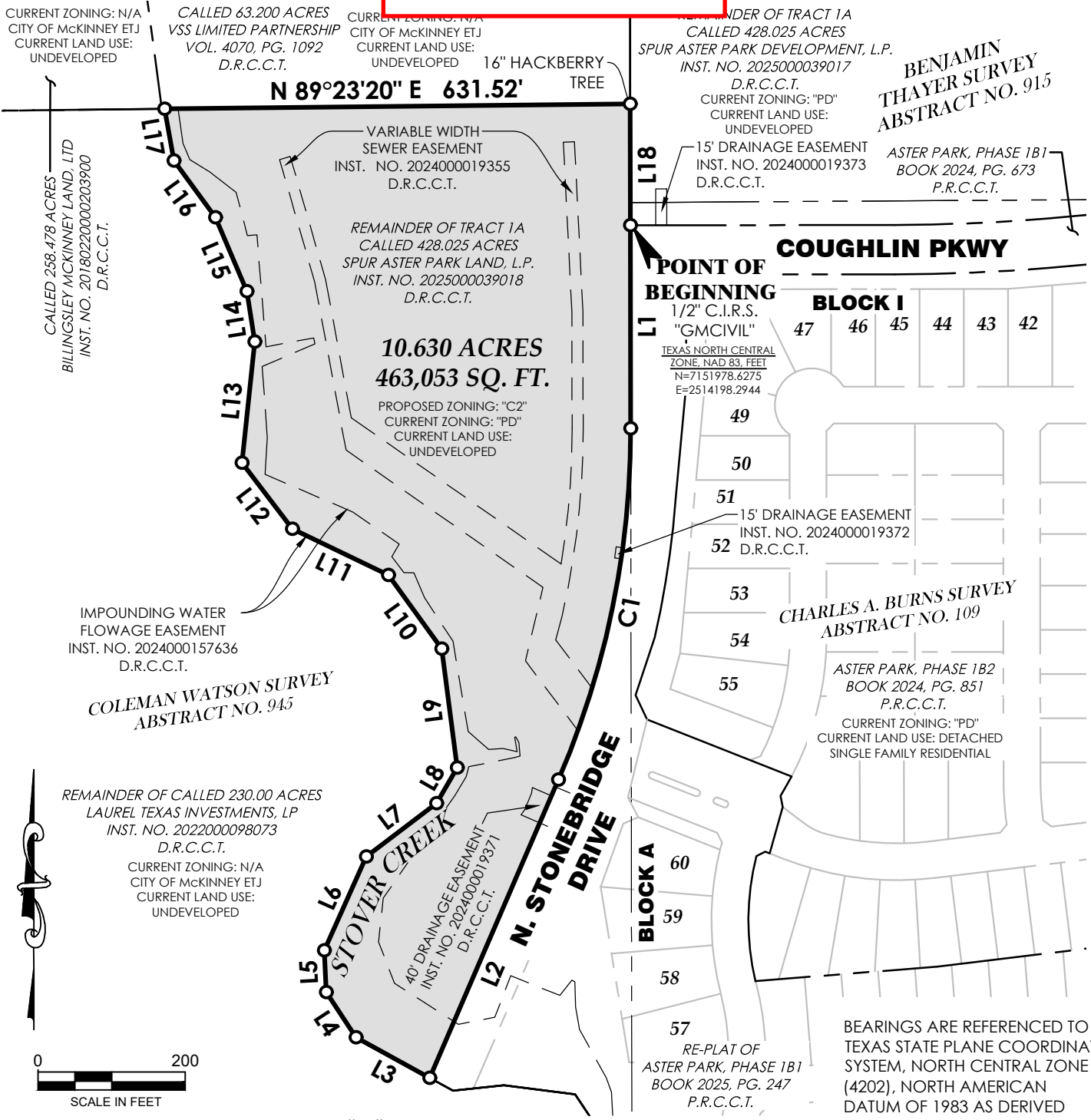

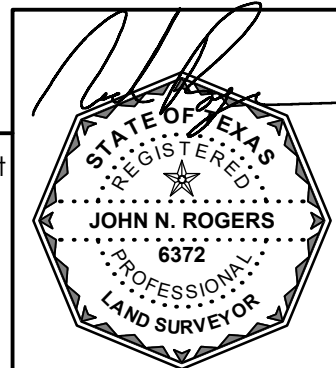
