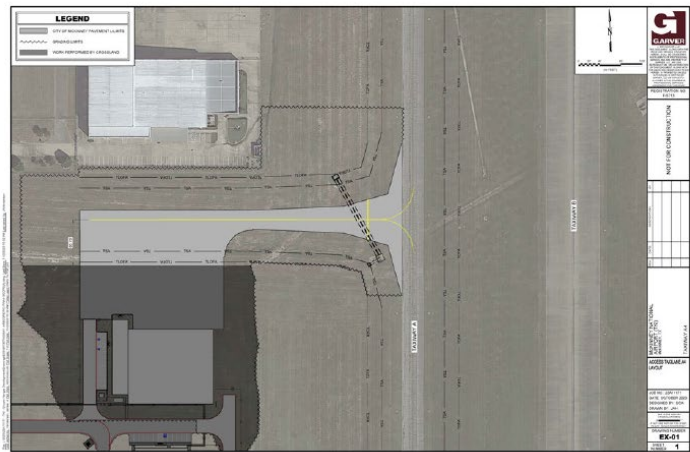
If request is approved, TIRZ 2 fund balance is estimated to be \$7.43 million at fiscal year end 2024.

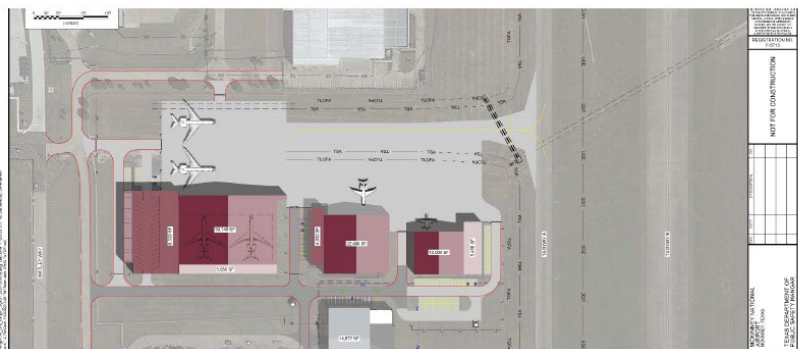


SCOPE OF WORK DIAGRAM

Annual net revenue from fuel sales & aeronautical services is estimated to be \$350,000

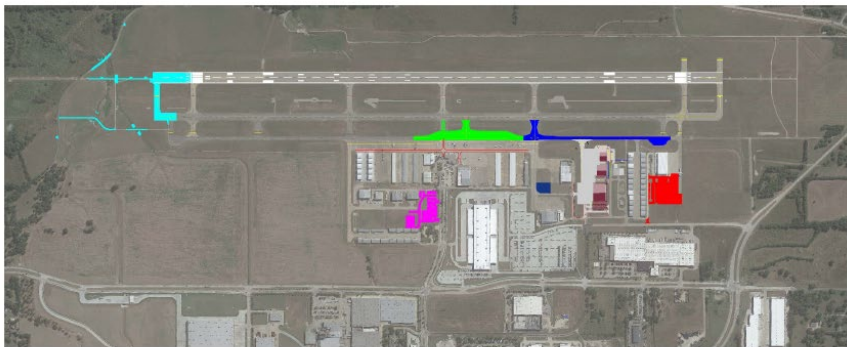
