**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS AUTHORIZING CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2024-2025 BUDGET FOR MCKINNEY CONVENTION & VISITORS BUREAU (MCVB), MCKINNEY ECONOMIC DEVELOPMENT CORPORATION (MEDC), AND MCKINNEY COMMUNITY DEVELOPMENT CORPORATION (MCDC); AND PROVIDING FOR AN EFFECTIVE DATE HEREOF**

**WHEREAS**, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2024-2025 Budget and submitted same to the City Council for its approval and a true and correct copy is attached.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2024-2025 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by re-appropriating \$36,457 from items carried from last fiscal year into the McKinney Convention & Visitors Bureau (MCVB) Fund.
- Section 3. The budget shall be amended by re-appropriating \$24,693,299 from various projects/items carried from last fiscal year into the McKinney Economic Development (MEDC) Fund.
- Section 4. The budget shall be amended by re-appropriating \$21,984,035 from various projects/items carried from last fiscal year into the McKinney Community Development (MCDC) Fund.
- Section 5. This Ordinance shall become effective from and after its adoption and is so ordained.
