**A RESOLUTION OF THE HISTORIC PRESERVATION ADVISORY BOARD OF THE CITY OF MCKINNEY, TEXAS, RECOGNIZING THE SERVICE AND EXPRESSING GRATITUDE AND CONGRATULATIONS TO JAYMIE PEDIGO FOR CONTRIBUTIONS TO HISTORIC PRESERVATION THROUGH THE HERITAGE GUILD OF COLLIN COUNTY AND CHESTNUT SQUARE HISTORIC VILLAGE IN MCKINNEY, TEXAS**

**WHEREAS**, it is appropriate to register the Board's appreciation for Ms. Pedigo's service and contributions.

**NOW, THEREFORE, BE IT RESOLVED BY THE HISTORIC PRESERVATION ADVISORY BOARD OF THE CITY OF MCKINNEY, TEXAS, THAT:**
