OWNERS' CERTIFICATE

BEGINNING at a 3/4 inch iron pipe found for the Southwest corner of said 0.7976 acre Heritage Christian Church tract, on the North right-of-way line of Greenville Road (a variable width R.O.W.) and same being the Southeast corner of a tract of land described in a deed to Carl W Watts and wife, Linda Nell Watts, recorded in

THENCE: North 08 deg. 04 min. 07 sec. West (Deed Call = N 08° 00′ 00″ W - 79.00′), departing from said Greenville Road and along the common line of said Heritage Christian Church and Watts tracts, a distance of 79.20 feet to a 1/2 inch iron rod topped with a plastic cap, stamped "ALS" (A.L.S. Land Surveying and hereinafter referred to as "with cap") found for the Northwest corner of said Heritage Christian Church tract and the Northeast corner of said Watts tract. Said corner also being on the South line of Ditto and Hights Second Addition, an addition to the City of McKinney according to the plat thereof, recorded in Volume 1, Page 47 of the Map & Plat Records of Collin County, Texas and being that same tract of land described in a deed to Glenn D. Davis, recorded in Volume 1640, Page

THENCE: North 74 deg. 30 min. 00 sec. East (Reference Bearing), along the common line of said Heritage Christian Church tract and Davis tract, a distance of 323.98 feet (Deed Call = 323.90') to a 1/2 inch iron rod, with cap, found for the Northeast corner of said Heritage Christian Church tract, on the West right-of-way line of Airport Drive as recorded in Volume 5763, Page 2307, DRCCT;

THENCE: South 27 deg. 26 min. 16 sec. East (Deed Call = S 27° 25′ 28″ E - 78.16′), along the common line of said Heritage Christian Church tract and Airport Drive, a distance of 78.27 feet to a 1/2 inch iron rod, with cap, found for the Southeast corner of said Heritage Christian Church tract at the intersection of the West right-of-way line of said Airport Drive and the North right-of-way line of the above mentioned Greenville Road;

THENCE: South 54 deg. 41 min. 58 sec. West (Deed Call = S 54° 36′ 23″ W - 72.15′), along the common line of said Heritage Christian Church tract and said Greenville Road, a distance of 72.18 feet to a 1/2 inch iron rod, with cap, found for corner at the beginning of a curve to the right, having a radius of 282.00 feet and a chord that bears South 71 deg. 56 min. 33 sec. West - 168.06 feet;

THENCE: Continuing along the common line of said Heritage Christian Church tract and said Greenville Road, through a central angle of 34 deg. 40 min. 24 sec. and along an arc distance of 170.66 feet to a 1/2 inch iron rod, with cap, found for corner at the end of said curve;

THENCE: South 89 deg. 10 min. 07 sec. West (Deed Call = S 89° 15′ 32″ W - 118.64′), a distance of 118.46 feet to a the POINT OF BEGINNING and containing 34,761 square feet or 0.798 acres of land.

THAT I, PIERCE SVOSVE, Pastor of HERITAGE CHRISTIAN CHURCH, do hereby adopt this Minor Plat designating the herein above described property as LOT 1, BLOCK A of HERITAGE CHRISTIAN CHURCH, an addition to the City of McKinney, Collin County, Texas, and do hereby dedicate to the public use forever, the streets and easements shown hereon for the purpose as indicated. The Firelane, Mutual Access and Utility Easement being hereby dedicated for the mutual use and accommodation of the City of McKinney and all public utilities desiring to use or using same. All and any public utility and the City of McKinney shall have the right to remove and keep removed all or parts of any building, fences, shrubs, trees, or other improvements or growths, which in any way, endanger or interfere with the construction, maintenance or efficiency of its respective systems on said easements, and the City of McKinney and all public utilities shall, at all times, have the full right of ingress and egress to or from and upon said easements for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining, and adding to or removing all or parts of its respective systems, without the necessity at any time, of procuring the permission of anyone.
