City of McKinney Summary

FY2024-2025 Annual Action Plan and Substantial Amendments under the 2020-2024 Consolidated Plan

The National Affordable Housing Act of 1990 (Housing Act), as amended and implemented under the U.S. Department of Housing and Urban Development (HUD) regulations at Part 24 CFR 91, requires the City of McKinney to create a five-year local strategic planning document, as the Consolidated Plan and submit one-year action plans annually. The FY 2024-2025 Annual Action Plan includes application for two programs to be administered by the city, known as the Community Development Block Grant (CDBG) and the HOME Investment Partnership (HOME) program, in accordance with Title 1 of the Housing and Community Development of 1974, as amended, under the reporting period of October 1, 2024 to September 30, 2025.

CDBG Program: The city anticipates receiving an allocation of \$ 912,415.00, to primarily benefit low-to-moderate income persons for eligible housing services, public services, community development activities, and grant administration. Proposed projects and activities eligibility are in accordance with Federal regulations 24 CFR Part 570, 24 CFR subpart b, Section 91.105 (c), Section 91.505 (a)(b). The balance of remaining amended funds available from previous program years and remaining CDBG-CV funding eligible to prevent or respond to the Coronavirus, available after September 30, 2024, will be used under the Housing Rehabilitation Program.

HOME Program: The 2020-2024 Consolidated Plan will be substantially amended to include anticipated funds of \$346,342.18 under the HOME Investment Partnership Program; the City of McKinney will abide by regulatory requirements under 24 CFR Part 92, upon approval of all designation requirements in progress under 24 CFR 91 and 24 CFR Part 92.102 to Part 92.104. Proposed funding will be used to bring additional affordable housing resources to benefit low-income households.

The Citizen Participation Plan and Language Access Plan have been updated to include current census data for language and the insertion of HOME funds.
