TAX INCREMENT REINVESTMENT ZONE NUMBER ONE (TIRZ1) BOARD AUGUST 27, 2024

The Tax Increment Reinvestment Zone Number One (TIRZ1) Board of the City of McKinney, Texas met in regular session in the Council Chambers, 222 N. Tennessee Street, McKinney, Texas on August 27, 2024 at 3:00 p.m.

TIRZ1 Board Chair Charlie Philips called the meeting to order at 3:12 p.m. upon determining a quorum of the Board consisting of himself and the following members were present: Board members George C. Fuller, Patrick Cloutier, Geré Feltus, and Michael Jones.

Board Vice Chair Rick Franklin, and Board members Justin Beller, Bry Taylor, and Darrell Hale were absent.

The Board provided feedback to staff to clarify which entity (i.e. TIRZ versus MEDC or MCDC) is appropriate for considering certain types of requests, and whether grant amount limits should be established. Board members Fuller and Philips expressed support for plan amendments to allow considerations on case-by-case basis. Board member Cloutier stated TIRZ1 exists primarily in District 1 and this discussion should include input from District 1 City Council member Beller who was absent. Director Arnold stated that staff provided an update on this item to Mr. Beller, who is expected to offer his feedback to City Manager Grimes. Board members Cloutier and Feltus requested that additional information be presented on Fire Suppression projects. Director Arnold stated an annual report including funding balance would be upcoming in the early portion of Fiscal Year 2024-25.
