AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY OF MCKINNEY, TEXAS, RELATING TO FEES, BY AMENDING THE CODE OF ORDINANCES SECTION 110-44, AND BY AMENDING APPENDIX A SCHEDULE OF FEES, IN PART, BY AMENDING SECTIONS 2-1, 86-23, 86-27, 86-28, 86-30, 86-32, 110-35, 110-37, 110-42, 110-44, 110-45, 110-139, 110-141, 110-142, 110-230, 110-395, AND 150-706D; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR PUBLICATION OF THE CAPTION OF THIS ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, the City Council of the City of McKinney, Texas, finds, determines, and declares that certain fees are necessary to provide for efficient government services; and

WHEREAS, the City Council of the City of McKinney, Texas, finds and determines that the current fees are insufficient to cover the costs of the respective services; and

WHEREAS, the City Council of the City of McKinney, Texas desires to adopt fees necessary for the City to provide good and efficient government for the benefit of the citizens of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The findings set forth above are incorporated into the body of this Ordinance as if fully set forth herein.

Section 2. The Code of Ordinances, City of McKinney, Texas, Section 110-44, is hereby amended to read as follows:

Sec. 110-44. Fire hydrant meter service deposits and requirements.

(a) When a city-owned fire hydrant meter is to be set, a service deposit ~~in an amount based on the current cost of a meter plus an administrative fee,~~ as determined from time to time by city council, will be required. A service charge as determined from time to time by city council shall be charged for each month (31 days) or fraction of a month in which a city-owned fire hydrant meter is used. ~~The service deposit may be reduced if a satisfactory and established credit rating is shown and acceptable to the city, in which case the service deposit shall be as determined from time to time by city council.~~

(b) A reduced pressure principle assembly (RPZ) that has been approved by the University of Southern California Foundation for Cross Connection Control and Hydraulic research shall be required protection for fire hydrant water meters which are being used for a temporary water supply during any construction or other uses which would pose a potential hazard to the public water supply.

(c) It is the responsibility of all persons engaging in the use and rental of a fire hydrant water meter to abide by the conditions of this article. All fire hydrant meters rentals shall meet the current requirements, as provided by the city.

Section 3. Appendix A, entitled "Schedule of Fees", of the Code of Ordinances, City of McKinney, Texas, Section 2-1, is hereby amended to read as follows

Appendix A, Section 2-1. Fees for special services provided by public works, development services, and parks and recreation departments.

- (a) Public works department services performed for individuals as special services, either on private property or not offered as a general public service shall be charged according to the actual cost of personnel, materials, and equipment, plus an overhead and administrative expense of 40 percent of actual service costs.
- (b) The charge/fee for services of the engineering department for review of construction of municipal infrastructure items, such as roadway improvements, drainage systems, water distribution systems and wastewater collection systems shall be calculated as follows:

City Inspection	\$1,500 Base Fee plus	\$2,279 per disturbed acre
City Total	\$3,000 Base Fee plus	\$3,191 per disturbed acre
ETJ Plan Review	\$2,000 Base Fee plus	\$1,215 per disturbed acre
ETJ Inspection	\$2,000 Base Fee plus	\$3,039 per disturbed acre
ETJ Total	\$4,000 Base Fee plus	\$4,254 per disturbed acre

- Subdivisions of ten or fewer residential lots under development by or for nonprofit builders of affordable housing as determined by the city housing division, or by or for the city housing finance corporation, shall be exempt from engineering inspection fees.
- (c) All persons requesting services that require one or more standard facilities agreement and/or development agreements shall be charged \$500.00 per agreement. Non-standard facilities agreements and/or development agreements shall be charged \$1,000.00 per agreement. City-initiated agreements shall have no fee.
 - (d) The services of the engineering department performed during the weekend or after 5:00 p.m. on a normal business day is \$82.00 per hour inside city limits and \$110.00 per hour outside city limits with a two-hour minimum.
 - (e) The charge/fee for the services of the engineering department for review of submittals for revocable license agreements regarding the limited use of city easements by the owner of the property burdened thereby for the installation or location of private improvements, such as signs, that do not interfere with the city's use of the easement shall be \$1,000.00.
 - (f) The charge/fee for services of the engineering department for review of floodplain reclamation activities shall be \$3,000.00 for the initial application and document review plus one subsequent submittal and document review of amended or corrected documents responding to and addressing the engineering department's comments. The charge/fee for each subsequent submittal and review of corrected documents responding to and addressing the engineering department's comments shall be \$1,000.00 each.
 - (g) The charge/fee for the services of the engineering department for review of submittals for tree permit processing and issuance shall be as follows:

¹ **Mixed Business Uses:** If a business includes two or more different types of uses (e.g., retail and restaurant), the Mixed Business Use will be charged at the higher rate.

DBD Types of Uses

The types of uses for occupants of buildings in the DBD are generally grouped together and classified as follows:

- 1. **Service/Office Uses:** Office space or service-related businesses (e.g., barber shop, travel agent, law office, small IT consulting, real estate agency).
- 2. **Retail Uses:** Businesses involving the sale of products directly to end consumers (e.g., boutique, antique shop, floral shop).
- 3. **Restaurant Uses:** Commercial establishments where food and non-alcoholic beverages are prepared and served and/or alcoholic beverages are also served (e.g., coffee shops, donut shops; sandwich shops, specialty food shops, and full-scale or limited menu restaurants;).

In addition, the following uses are identified as separate from the groups of classifications identified above and are analyzed separately and distinctly upon request:

- 1. **Hotel Uses:** High regardless of square footage.
- 2. **Church Uses:** Medium regardless of square footage.
- 3. **Residential Uses:** Low rate charged per dwelling unit.

Please note that the impacts of the maximum occupancy rates for the uses classified herein have not yet been fully studied and determined and included in these charts. Those impacts will be further evaluated and may be included in the future to more specifically narrow down or modify the groupings identified, the impacts of each grouping or classification and increase or decrease the fees for such groupings.

 - c. Mobile home parks: One SFLUE per each mobile home pad or trailer pad.
 - d. Multifamily properties: No. of SFLUE for property = Square footage of impervious surface on property/3,000 square feet, rounded up to the nearest whole number with a minimum of one SFLUE.
 - e. Nonresidential, commercial and/or industrial properties: No. of SFLUE for property = Square footage of impervious surface on property/3,000 square feet, rounded up to the nearest whole number with a minimum of one SFLUE.
- (2) *The system-wide component.* The monthly system-wide fee, per SFLUE for all property situated within the city shall be calculated based on the following classifications:
 - a. For all residential uses including single family, townhomes, duplexes, quadplexes, mobile home parks, and multi-family properties ~~\$4.50~~ \$5.25
 - b. For nonresidential, commercial and/or industrial properties ~~\$3.50~~ \$4.25
- (3) The lake drainage basin component. The monthly system-wide fee, per SFLUE for all property within the city0.00
- (4) The preferred method for calculating the SDUS fee due and payable from a user and/or benefited property on a monthly basis is to multiply the number of SFLUE for the particular use of the property by the sum of the system wide component fee and the lake drainage basin component fee, which calculation reads as follows:

No. of SFLUE × (system wide component fee + lake drainage basin fee)
- (5) For those properties identified hereinabove in subparagraphs (1)d. and (1)e. the following alternative calculation may be performed on a monthly basis to determine the SDUS fee due:

(Square footage of impervious surface/1,000 square feet) × [(system wide component fee + lake drainage basin fee)/3], rounded up to the nearest whole number.
- (5) The amount of the SDUS fee billed to a nonresidential, commercial or industrial property may be reduced by a percentage equal to the BMP credit approved for the property pursuant to the city's stormwater credit program.

If any section, subsection, paragraph, sentence, phrase or clause of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and to this end, the provisions of this Ordinance are declared to be severable.
- Section 21. This Ordinance shall be cumulative of all other ordinances of the City and shall not repeal any of the provisions of said ordinances except in those instances where provisions of those ordinances are in direct conflict with the provisions of this Ordinance and such ordinances shall remain intact and are hereby ratified, verified and affirmed.
- Section 22. The caption of this Ordinance shall be published one time in a newspaper having general circulation in the City of McKinney.

Section 23. This Ordinance shall become effective October 1, 2025.
