**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE AWARD OF A CONTRACT TO GREEN DREAM INTERNATIONAL, LLC OF ERIE, PENNSYLVANIA, VULCAN CONSTRUCTION MATERIALS, LLC OF SAN ANTONIO, TEXAS AND JCL L4 CONSTRUCTION, LLC OF DODD CITY, TEXAS FOR STREET MATERIALS**

**WHEREAS,** the City Council of the City of McKinney, Texas, has determined the need for street materials and,
