A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A SUPPLEMENTAL AGREEMENT WITH FREESE AND NICHOLS, INC. FOR ADDITIONAL ENGINEERING DESIGN SERVICES FOR THE LELA, JONES, FOOTE AND BRADLEY STREET INFRASTRUCTURE PROJECT FOR AN INCREASE IN THE NOT TO EXCEED FEE FROM \$550,000 TO A TOTAL AGGREGATE CONTRACT AMOUNT, INCLUSIVE OF ANY ADDITIONAL SUPPLEMENTAL AGREEMENTS, NOT TO EXCEED \$620,000

WHEREAS, the City Council of the City of McKinney, Texas, recognizes the need for the additional design services for the Lela, Jones, Foote, and Bradley Street Infrastructure Improvements Project (CIP Projects ST2134, WW2134 and WA2134); and

WHEREAS, the City has received a proposal from Freese and Nichols, Inc. to provide additional design services for the Lela, Jones, Foote, and Bradley Street Infrastructure Improvements Project (CIP Projects ST2134, WW2134 and WA2134).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. The City Manager is hereby authorized to execute a supplemental agreement with Freese and Nichols, Inc. to provide additional professional engineering services for the design of the Lela, Jones, Foote, and Bradley Street Infrastructure Improvements Project (CIP Projects ST2134, WW2134 and WA2134) for an increase in the not to exceed fee from \$550,000 to a total aggregate contract amount, inclusive of any additional supplemental agreements, not to exceed \$620,000.
- Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
