## Project Grants

Applications for the first cycle of MCDC Project grants will be accepted December 1-31.
 Public hearings on applications that are submitted will be scheduled for the January 2024 board meeting.
 Board action will take place at the February 2024 board meeting.

## Retail Development Infrastructure Grants

- Gant program created to provide funding support for infrastructure improvements for landmark retail properties within the City of McKinney.
- o Maximum award for any single grant is 75% of total cost of the infrastructure improvements up to a maximum of \$50,000.
- 25% to be provided by the property owner or tenant. Funds secured from other City of McKinney sources (TIRZ, Community Grants, etc.) may not be used for the owner/tenant match.
- o "Landmark Retail" is defined as retail buildings within the historic downtown area with boundaries that coincide with the "Cultural District" designation; and retail redevelopment opportunities at locations that are viewed as gateways into the city (e.g., Highway 5 and Spur 399 and other locations along Highway 5; Virginia Parkway and 75).
- Eligible Improvements: infrastructure improvements, for retail establishments or buildings housing a retail enterprise, that are <u>exterior to a property</u>, and <u>necessary to promote or</u> <u>develop new or expanded business enterprises:</u>
  - Sewer
  - Water
  - Electric Utilities
  - Gas Utilities
  - Drainage
  - Lighting (for security enhancements)
  - Fencing (for security enhancements)
  - Site Improvements
    - (Landscape <u>only considered if replacement required due to infrastructure improvements</u>)
    - Walkways concrete or other materials
    - Parking
    - Fire suppression systems


Below is a high-level recap of work progress and photos.

#### November 1 – November 4

Site: Locating Storm Drains, gas to firepits; Tap Room: Removing Grain from Silos, Install stairs and handrails, piping to water heater room, fire alarm; Brewery: Punch List work













November 6 – November 11


Site: Remedial work to Dumpster Gates, ; Tap Room: Piping Equipment in Water Heater Room, ; Barrel Aging: clear out misc items stored;













## November 13 - November 18

Site: Set blocks around site, remediation of damaged landscape, continue changes for ADA compliance, bringing site drains up to correct elevation; Tap Room: clean up of grain ; Brewery: rework of flooring at Brewhouse, punch list and clean

















## November 20 - November 23 (Thanksgiving week)

Site: weather delayed some site work, continue DG around site; Brewery: ; Tap Room: Mezzanine joist install, installing sprinkler heads, chlorination of domestic water system, clean up, sealing off existing interior grain silos, touch up paint, adjusting doors, insulate plumbing lines, ADA corrections to floor, passed mechanical and plumbing rough-in inspections; Barrel Aging: Fire alarm and Fire sprinkler inspection – failed both,









November 27 - November 30

Site: continue raising site drains, power wash fire lane,; Tap Room: continue insulating pipe and flooring repairs, review of smoker to provide required clearance- move electrical; Brewery: clean floors from brewhouse flooring work,
