## **RESOLUTION NO. 2025-4-\_\_(R)**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, SHOWING SUPPORT FOR THE EFFORTS OF THE MCKINNEY HOUSING AUTHORITY TO PARTNER WITH PRESIDIUM TO CONSTRUCT A NEW AFFORDABLE HOUSING DEVELOPMENT TO BE KNOWN AS COTTON MILL PHASE I

- WHEREAS, the City of McKinney, Texas, ("City") is a home rule municipality organized pursuant to Article 11, Section 5 of the Texas Constitution, certain provisions of the Texas Local Government Code, and its Home Rule Charter ("Charter"), and possesses the full power of local self-government; and
- **WHEREAS,** the City Council of the City of McKinney, Texas, ("City Council") supports the creation and preservation of affordable housing; and
- WHEREAS, the City Council has adopted a number of objectives or goals for the City including Goal 1B, to "Provide a strong city economy by implementing a Global Housing Strategy with a focus on affordable housing and facilitating a balance between industrial, commercial, residential, and open space"; and
- WHEREAS, the McKinney Housing Authority plans to partner with Presidium through a Texas limited partnership to develop a new proposed two-hundred fifty-seven (257) unit apartment complex at the southeast quadrant of Elm Street and Amscott Street, more commonly known as 610 Elm Street, in the City of McKinney to be known as the "Cotton Mill Phase I," and has requested a letter of support regarding that proposed development from the City of McKinney; and
- WHEREAS, the City Council desires to show its support for the McKinney Housing Authority's efforts through its limited partnership to establish a quality affordable housing development that includes affordable units at both the 30% "AMI" (as defined below) level and the 80% "AMI" level; and
- WHEREAS, it is deemed necessary and advisable that this Resolution be adopted;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS THAT:

- Section 1. McKinney Housing Authority ("MHA") and Presidium have committed to designate at least one hundred sixteen (116) units, or approximately forty-five percent (45%), of the total 257 new units proposed for construction within the Cotton Mill Phase I as affordable apartment units set aside for residents with incomes at or below eighty percent (80%) of the Area Median Income ("AMI") as determined by the U.S. Department of Housing and Urban Development ("HUD") ("Affordable Housing Units").
- Section 2. MHA and Presidium have committed to setting aside at least thirteen (13), or approximately five percent (5%), of the total 257 new units proposed for construction within the Cotton Mill Phase I as affordable apartment units set aside for residents with incomes at or below thirty percent (30%) of the AMI (also "Affordable Housing Units").
- Section 3. MHA projects that the two classifications of designated Affordable Housing Units at the Cotton Mill Phase I will result in approximately \$8,188,649 in rental savings to the McKinney community over a ten-year period.
- Section 4. The City Council understands that the Cotton Mill Phase I once developed by the MHA public/private partnership with Presidium will become public property used for essential public and governmental

purposes and will be exempt from all taxes and special assessments of a municipality, a county, another political subdivision, or the State of Texas in accordance with and subject to the property owner's compliance with Section 392.005 of the Texas Local Government Code.

- Section 5. The City Council recognizes the benefits of the MHA public/private partnership with Presidium to develop the Cotton Mill Phase I in furthering the City's goal to establish additional affordable housing within the City of McKinney.
- Section 6. The City Council hereby expresses its support for the MHA's public/private partnership with Presidium to construct a new affordable housing development to be known as the Cotton Mill Phase I in conformity with the City's development regulations and all applicable building codes.
- Section 7. The City Council hereby directs that a duplicate original of this Resolution be provided to the McKinney Housing Authority showing the City of McKinney's support for their proposed development of the Cotton Mill Phase I through a proposed public/private partnership and in conformity with the City's development regulations and all applicable building codes.
- Section 8. This Resolution shall be effective immediately upon its passage.
