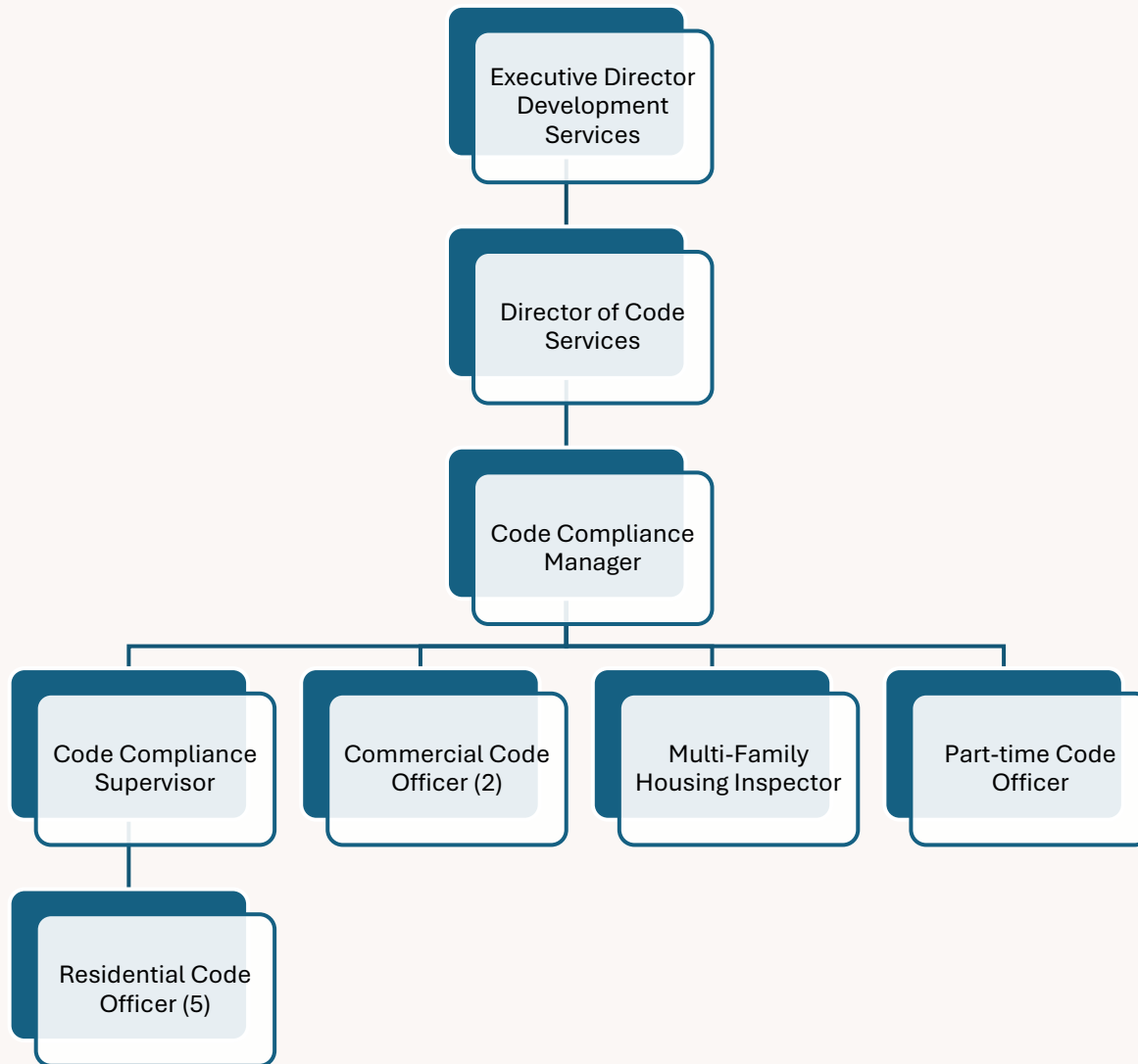

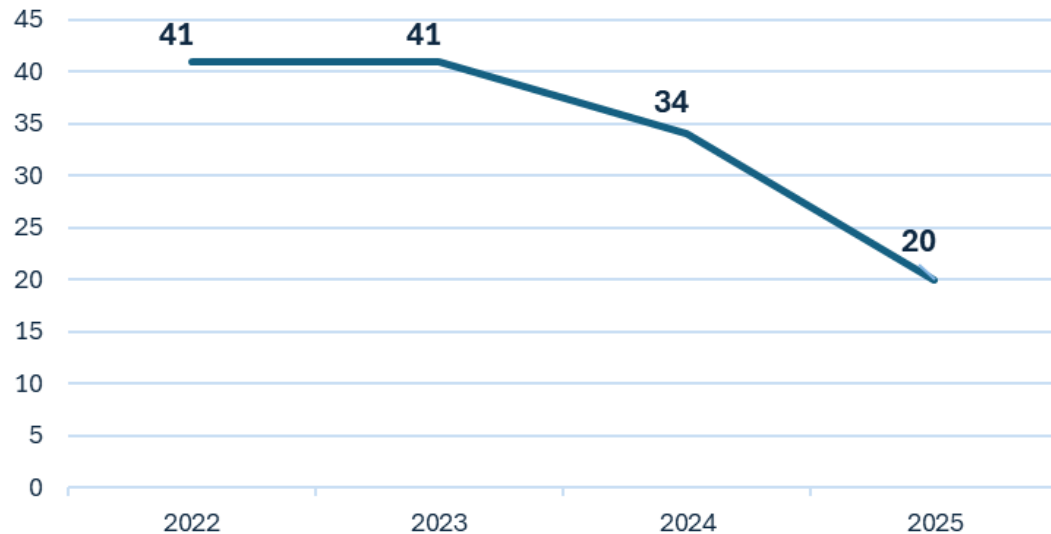

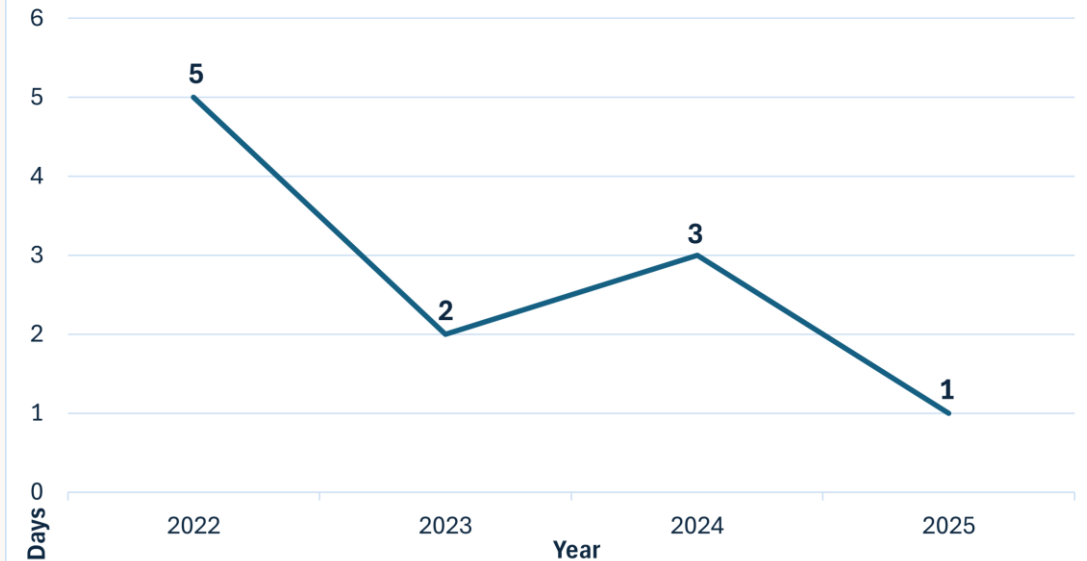

Case Duration (Days)



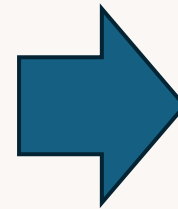
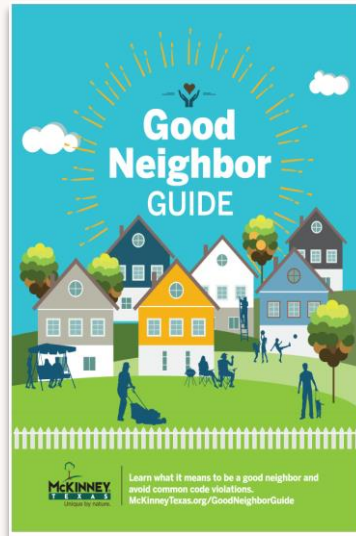
Complaint Response Time

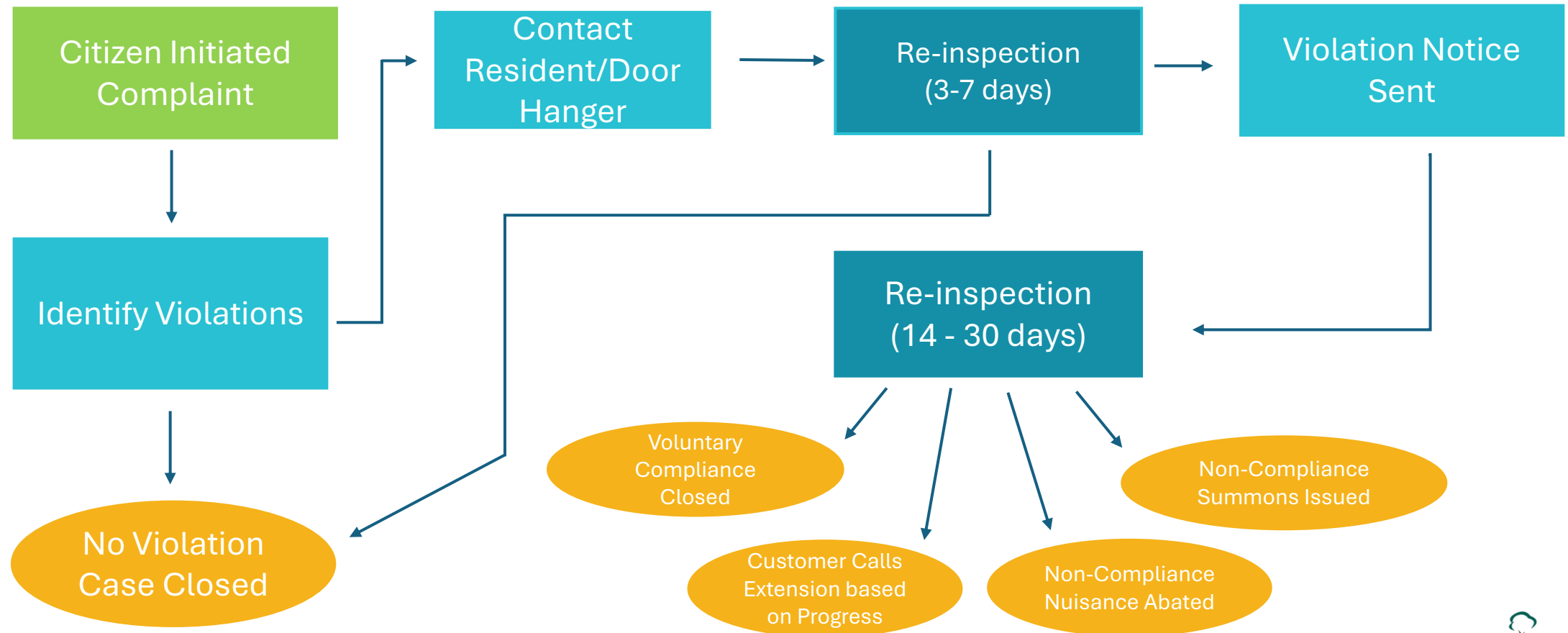

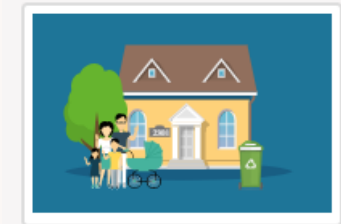
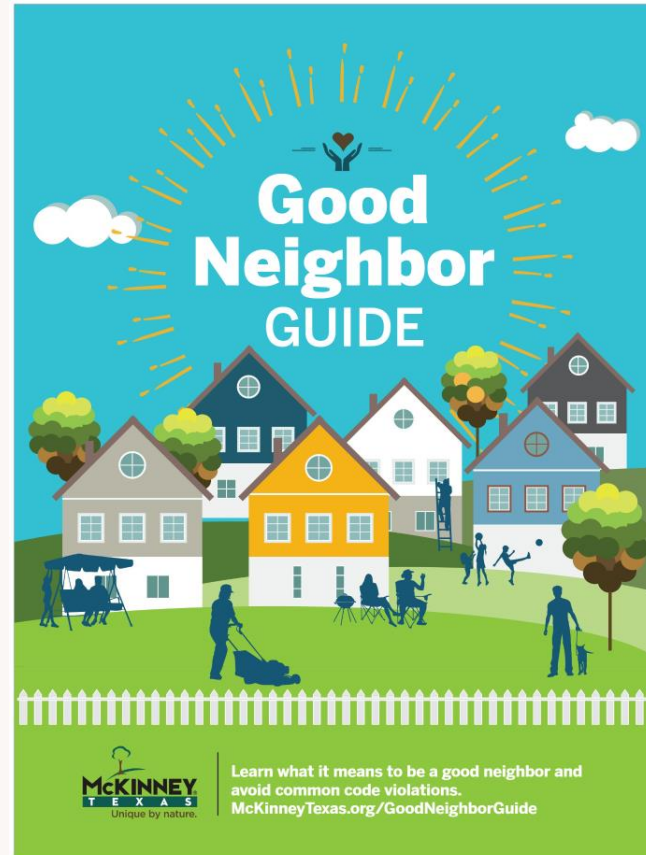
Compliance Case Flow Chart
