Caitlyn Strickland, Planning Manager with the City of McKinney, called the meeting to order at 6:00 p.m. after determining a quorum was present.

Chairman Cox continued the meeting with the Regular Agenda Items and Public Hearings on the agenda.

24-0057Z2 Conduct a Public Hearing to Consider/Discuss/Act on a Request to Rezone the Subject Property from "BN" - Neighborhood Business District to "PD" - Planned Development District, Generally to Modify the Development Standards and to Allow for Warehouse and Commercial Uses, Located at 100 East Leland Avenue

Cameron Christie, Planner I with the City of McKinney, presented the item. The Commission asked questions which were addressed by Staff. Jennifer Arnold, Director of Planning with the City of McKinney, answered questions asked by the Commission. John Sharker, 574 CR 5850 Leonard, TX, applicant, explained the request and answered questions. Chairman Cox opened the public hearing and called for comments. There were none. On a motion by Vice-Chairman Lebo, seconded by Commission Member Wattley, the Commission unanimously voted to close the public hearing with a vote of 7-0-0.
