Process

The McKinney Community Development Corporation Board of Directors are responsible for reviewing and voting on applications for grant funding, in accordance with requirements of the Texas Local Government Code.

- A **completed** application form must be submitted via the online form in accordance with the 2025 schedule outlined on page one.
- The application will be evaluated to determine eligibility for MCDC funding under State law.
- A minimum of two bids must be secured for the proposed work and be included with the application. (A certified estimate may be accepted with the application if the timeframe for the bid expires earlier than the timeframe for the application, presentation and decision on the funding request.)
- Once eligibility for consideration is confirmed, Applicants will be notified and placed on the meeting agenda to make a presentation to the Board. Following the presentation, Board member will have an opportunity to ask questions of the applicant. Please note: This is a formal presentation and time limits may be imposed.
- A public hearing, with notice of application and request for funding, will be published and posted in accordance with the requirements of the Open Meetings Act and the Texas Local Government Code. **The application, along with all documents/attachments will become public information once submitted to MCDC.**
- Following the public hearing, grant requests will be referred to a subcommittee of the MCDC board for evaluation and recommendation of approval or denial to the full board.
- Board action on the grant application will be scheduled for the board meeting the month following the public hearing.

McKinney National Airport (TKI) was established in 1979 as a general aviation airport. The long range plan for the airport has always been to maximize the economic impact of the airport on the City of McKinney, Collin County and the region. In 2013, the City of McKinney acquired the McKinney Air Center fixed based operator (FBO), taking on hangar ownership and rental, fuel sales, and aeronautical services at TKI. Development of the airport has always been on the west side of the runway, but available land on the west side is running short, necessitating development of the east side. The City of McKinney purchased approximately 190 acres of land on the east side in 2018 to facilitate future development. The City Council has directed staff to begin design of the east side, including needed infrastructure such as taxiways, ramp space, parking, and utilities. Design of the infrastructure is nearing completion and the council has directed staff to move forward with construction of the infrastructure as well as a commercial passenger service terminal. The proposed terminal will expand TKI from general aviation only to a full service airport offering general aviation and commercial passenger service.

The requested funds will be used in conjunction with the MEDC grant funds and city funds to fund the construction of the eastside airport infrastructure and passenger terminal. The MCDC portion of the funding will go towards the capital improvements that are permitted under state statute for the MCDC, but that are not permitted to be funded by the MEDC. The MCDC funded improvements include taxiways, aprons and airport facilities that may include hangars and/or terminals.

Days / Hours of Business Operation

The airport operates 24 hours a day and 365 days a year. The FBO terminal currently operates 6:00 am to 10:00 pm daily, with after hours service on request.

The proposed infrastructure will enable development of various aviation uses on the east side of the airport. The plan is to maximize flexibility to allow for growth in the future as the market and economy dictate. The proposed terminal is a small phase one terminal that is expandable, but is intended as a relatively inexpensive terminal to prove that commercial service is viable at TKI. If commercial service is successful, future expansion would include the construction of an entirely new terminal north of the first phase. The first phase terminal would continue to offer gates for the terminal or could be repurposed as a maintenance facility and/or rental car facility.

- Grant funding is provided on a reimbursement basis subsequent to submission of a reimbursement request, with copies of invoices and paid receipts for qualified expenses.
- Up to 20% of the grant funds awarded may be withheld **until a final report on completion of the Project is provided to MCDC.**
- A performance agreement will be required that may outline requirements for acknowledging MCDC funding support for the project. Additionally, it will contain a provision certifying that the applicant does not and will not knowingly employ an undocumented worker in accordance with Chapter 2264 of the Texas Government Code, as amended. Further, should the applicant be convicted of a violation under 8 U.S.C. § 1324a(f), the applicant will be required to repay the amount of the public subsidy provided under the agreement plus interest, at an agreed to interest rate, not later than the 120th day after the date the MCDC notifies the applicant of the violation.
