A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREMENT WITH THE MCKINNEY INDEPENDENT SCHOOL DISTRICT FOR EMS STANDBY SERVICES AT MISD EVENTS

- WHEREAS, the City Council of the City of McKinney, Texas, ("City Council") is committed to fostering a safe and secure community and supporting collaborative partnerships that enhance public safety; and
- WHEREAS, the McKinney Independent School District ("MISD") has requested on-site Emergency Medical Services ("EMS") standby coverage at designated school events, including football games and other large gatherings; and
- WHEREAS, the City of McKinney ("City"), acting by and through the McKinney Fire Department ("MFD"), is authorized pursuant to Chapter 791 of the Texas Government Code (the Interlocal Cooperation Act) to enter into cooperative agreements with other governmental entities, and
- **WHEREAS**, the proposed Interlocal Agreement ("ILA") formalizes EMS standby coverage, event scheduling procedures, staffing flexibility, and cost-recovery terms to ensure the safety and well-being of students, staff, and attendees; and
- WHEREAS, under the ILA, MISD will reimburse the City at rates of \$61.45 per hour per firefighter/paramedic (4-hour minimum) and \$100 per event for medical supply setup and restocking, with payment due within 45 days of invoice; and
- **WHEREAS**, the City Council finds that authorizing the ILA supports the Council Goal of a Safe and Secure Community.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. All of the above premises are hereby found to be true and correct and are hereby approved and incorporated into the body of this Resolution as if set forth in their entirety.
- Section 2. The City Council of the City of McKinney, Texas hereby approves the Interlocal Agreement with the McKinney Independent School District for EMS standby services at MISD Events.
- Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
