

**RESOLUTION NO. 2025-10-XXX (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING AND AUTHORIZING THE CITY MANAGER TO EXECUTE (1) THE SECOND AMENDMENT AND EXERCISE OF OPTION TERM OF THE INTERLOCAL COOPERATION AGREEMENT BETWEEN THE CITY OF MCKINNEY AND DALLAS AREA RAPID TRANSIT MOBILITY SERVICES, LOCAL GOVERNMENT CORPORATION AND (2) THE RELATED SECOND AMENDMENT AND EXERCISE OF OPTION TERM OF THE INTERLOCAL COOPERATION AGREEMENT FOR "GOPASS®," SUBSCRIPTION AND LICENSE**

**WHEREAS,** the City of McKinney, Texas (the “City”) is a Home Rule City possessing the full power of local self-government pursuant to Article XI, Section 5 of the Texas Constitution, Section 51.072 of Texas Local Government Code and its Home Rule Charter; and

**WHEREAS,** the City entered into two Interlocal Cooperation Agreements (“ILAs”) with Dallas Area Rapid Transit Mobility Services, Local Government Corporation (“DART”) to provide transit services for the McKinney Urban Transit District (“MUTD”) on or about November 15, 2021; and

**WHEREAS,** the initial term of the ILAs was scheduled to expire five years later unless the City requested, and DART agreed to extend the ILAs for up to two additional one-year option terms; and

**WHEREAS,** the City Council of the City of McKinney, Texas (“City Council”) authorized the City Manager to seek an extension of the ILAs with DART on May 21, 2024, and DART agreed to the extensions; and

**WHEREAS,** the McKinney Urban Transit District (“MUTD”) Board requested that the City Manager seek the second extension of the ILAs with DART on June 3, 2025, and DART agreed to the extensions; and

**WHEREAS,** DART and the City desire to amend and extend the ILAs for the benefit of the McKinney Urban Transit District and the residents residing in the City as well as the McKinney Urban Transit District Area.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. The foregoing premises are found to be true and correct and are hereby incorporated into the body of this Resolution by reference as if set forth in their entirety.
- Section 2. The City Council of the City of McKinney, Texas does hereby approve and authorize the City Manager to execute (1) the Second Amendment and Exercise of Second Option Renewal of the Interlocal Cooperation Agreement between the City of McKinney and Dallas Area Rapid Transit Mobility Services, Local Government Corporation and (2) the related Second Amendment and Exercise of Second Option Term Renewal of the Interlocal Cooperation Agreement for "GoPass®" Subscription and License thereby extending the ILAs for one additional one-year term.
- Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
