MINUTES CITY OF MCKINNEY, TEXAS COMMUNITY GRANTS ADVISORY COMMISSION WEDNESDAY, JUNE 16, 2010, 6:30 PM COMMUNITY SERVICES ANNEX B CONFERENCE ROOM

The Community Grants Advisory Commission (CGAC) of the City of McKinney, Texas, met in regular session in the Community Services Conference Room, 314 South Chestnut, Suite 101 on Wednesday, June 16, 2010 at 6:30 p.m.

Commission members present were Rachelle Campbell, Brenda Carter, Jeff Datgatz, Ada Simmons, and Aaron McMahon. Member Kim Hubbard-Hall was not in attendance. CDBG Administrator, Shirletta Best and CDBG Coordinator, Christine Lawton represented City staff.

Chairperson McMahon called the meeting to order at 6:34 p.m.

The first item on the agenda was the review and approval of the minutes from the May 19 and May 20, 2010 public hearings. Chairperson McMahon motioned to accept both sets of minutes and Ms. Campbell seconded. The motion passed unanimously 5-0.

Chairperson McMahon addressed the next agenda item, the election of Vice Chair. Chairman McMahon asked for a nomination from the floor for the Vice Chair position. Ms. Simmons made a motion of nomination for Ms. Campbell to become Vice Chair and Mr. McMahon seconded. The motion passed unanimously 5-0.

Next agenda item was the CDBG program updates, FY 2009-10. Ms. Best stated that this Monday, June 21, 2010, the City of McKinney is hosting a Boards & Commissions Reception at 5:30 for residents who would like to learn more about serving as a board member. Ms. Best encouraged the board members to attend this function to learn about other City boards they could serve on when there CDAC terms are finished. Ms. Best also expressed gratitude for the time Mr. Hardesty served on the board and as a Vice-Chair and proudly announced that Ms. Carter will be serving an additional term. Ms. Best then gave a brief update concerning the consolidated plan.

The next agenda item was to open the floor for public comments regarding the 2010-11 CDBG funding request under the Housing Rehabilitation Program and Grant Administration. Ms. Best explained the allocation of funding for Public Services, Housing Rehabilitation and Administrative Costs. Chairperson McMahon the asked if there were any comments from the public. No public was present at the time of the meeting. The public hearing was then closed.

Next was the consideration, discussion and action on funding allocations for all Community Development Block Grant funding requests. Each Commissioner prepared recommendations for each agency applying prior to the deliberations meeting. The funding amounts were inserted into an Excel spreadsheet that averaged individual recommendations into a grant award amount for consideration.

The total of grant recommendations under public services program are subject to a regulatory cap of fifteen percent of the total CDBG grant award (\$89,556) and funding under grant administration is also subject to a regulatory cap of the total grant award at twenty percent of the grant (\$119,409). After considerable discussion, the Commission confirmed the final spreadsheet and reached the consensus on the following allocations:
