**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF
McKINNEY, TEXAS AUTHORIZING CERTAIN BUDGET AMENDMENT
PERTAINING TO THE FISCAL YEAR 2025-2026 BUDGET FOR
MCKINNEY ECONOMIC DEVELOPMENT CORPORATION (MEDC)
AND MCKINNEY COMMUNITY DEVELOPMENT CORPORATION
(MCDC); AND PROVIDING FOR AN EFFECTIVE DATE HEREOF**

WHEREAS, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2025-2026 Budget and submitted same to the City Council for its approval and a true and correct copy is attached.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
McKINNEY, TEXAS, THAT:**

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2025-2026 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by re-appropriating \$19,921,603 from various projects/items carried from last fiscal year into the McKinney Economic Development Corporation (MEDC) Fund.
- Section 3. The budget shall be amended by re-appropriating \$23,794,189 from various projects/items carried from last fiscal year into the McKinney Community Development Corporation (MCDC) Fund.
- Section 4. This Ordinance shall become effective from and after its adoption and is so ordained.
