AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS AUTHORIZING CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2021-2022 BUDGET FOR MCKINNEY CONVENTION & VISITORS BUREAR (MCVB), MCKINNEY ECONOMIC DEVELOPMENT CORPORATION (MEDC), AND MCKINNEY COMMUNITY DEVELOPMENT CORPORATION (MCDC); AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2021-2022 Budget and submitted same to the City Council for its approval and a true and correct copy is attached.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2021-2022 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by re-appropriating \$50,000 from various projects/items carried from last fiscal year into the McKinney Convention & Visitors Bureau (MCVB) Fund.
- Section 3. The budget shall be amended by re-appropriating \$15,152,028 from various projects/items carried from last fiscal year into the McKinney Economic Development (MEDC) Fund.
- Section 4. The budget shall be amended by re-appropriating \$34,407,402 from various projects/items carried from last fiscal year into the McKinney Community Development (MCDC) Fund.
- Section 5. This Ordinance shall become effective from and after its adoption and is so ordained.
