AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS AUTHORIZING CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2021-2022 BUDGET AND THE 2022-2026 CAPITAL IMPROVEMENTS PROGRAM FOR THE MUNICIPAL COMPLEX PROJECT (FC1707); AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2021-2022 Annual Budget and the Fiscal Year 2022–2026 Capital Improvements Program and submitted same to the City Council for its approval and a true and correct copy is attached.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2021-2022 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by appropriating \$1,000,000 from the General Fund balance, transferring it to the Facilities Improvement Fund and appropriating it in the CIP Project FC1707 Municipal Complex.
- Section 3. The budget shall be amended by transferring \$2,000,000 from the Water/Wastewater Fund appropriations to the Facilities Improvement Fund and appropriating it in the CIP Project FC1707 Municipal Complex.
- Section 4. This Ordinance shall become effective from and after its adoption and is so ordained.
