



## Automated Vehicles Program 2.0 - AV2.2/2.3 Program Funding

- \$4,937,339 in Federal Funding
- \$250,000 in Matching Funds

## Program Focus – Health Equity

- Supporting Underserved Community
  Members in McKinney & South Dallas, Texas
  - Focus on:
    - Families Living in Poverty
      - McKinney 13,308 individuals living at or below the federal poverty level
         South Dallas – 88,957 individuals living at or below the federal poverty level
    - · Individuals with Disabilities
    - Seniors
- Increase Access to Healthcare,
  Prescriptions, & Healthy Food via
  Autonomous Vehicle informally called the "Wellness Wagon"





## Feonix Wellness Wagon AV Services

- Telehealth at Individual Residence Parked in Driveway or Parking Lot
- Telehealth at Facility such as WIC Sign-up Location or Outside Senior Adult Day Center
- Delivery of Medications (Non-Narcotic)
- Delivery of Healthy & Fresh Food











## Feonix Wellness Wagon AV Services

- Wide Variety of Telehealth/Telemedicine Services Able to be Performed in the Vehicle to Support Patients:
  - Mental Health
  - Physical Health
  - High Risk Pregnancy
  - Chronic Illness
  - Nutrition Counseling
  - Asthma Treatment
- Medication Delivery Needed that Reduces ER Utilization:
  - Insulin
  - Albuterol
  - Others as Defined by Healthcare Providers
- Food Box Delivery Optimizes Vehicle Utilization due to Flexibility of Delivery Times







## Geography

The pilot will explore teleoperation in a variety of contexts ranging from gravel roads on the outskirts of McKinney to the brick historic inner-city streets of South Dallas.

## McKinney – Suburban & Semi-Rural





**Dallas** – Focus on *South Dallas* - Highly Urban & Aging Infrastructure

### **AV Deployment & Operation**

- Phased Deployment of 2 Feonix Wellness Wagon AV vehicles based in McKinney
  - Suburban Areas with Low Population Density & New Well-Designed Infrastructure & Signage
  - Rural Areas with Gravel Roads, Older Asphalt, & Limited Signage
- Phased Deployment of 2 Feonix Wellness Wagon AV vehicles based in Dallas
  - Services Focus in South Dallas Urban Areas with High Population Density & Variety of Street Conditions





## **Automation Phases for AV Teleoperation**

**Phase 1:** Teleoperation with Safety Driver in Residential & Rural Routes/Deliveries

**Phase 2:** Teleoperation with Safety Driver in Residential, Rural, & Urban Routes/Deliveries


**Phase 3:** Teleoperation Independently for Established Reoccurring Routes/Deliveries and Customers Familiar with the Wellness Wagon

When the vehicle is being driven in teleoperation mode the safety driver will be free to make notes and complete the patient reports (optimizing the drive time) as well as call and prepare the next patient to be ready for arrival, and check-in on patients that were visited the previous day.
