- 22-0331 Chairperson Jennifer Mott called for an Update on 2022 McKinney Board & Commission Member Appointments. It was briefly discussed with the board. Presented a list of which board members would be up and eligible for renewal.
- Chairperson Jennifer Mott called for Consider/Discuss Consolidated
  Grants 2022-2023 Grant Review Schedule. Camille Smith presented the
  board with a McKinney Reviewer Training video created by
  representative for ZoomGrants for use by the Commissioners
- 22-0184 Chairperson Jennifer Mot called for Consider/Discuss Program Updates: Community Development Block Grant, Community Support Grant, and Community Development Activities. Camille Smith spoke on behalf of Community Support Grants (CSG) and stated that currently last report indicated that 4 agencies are at 100%, 5 agencies are at 50% or more, 6 agencies are at 30% but are on track, and 1 agency is at 20% but feel that they will meet the expectations before the year is up.
