REPORTS

Board Chair Vincent Vittatoe called for Board and Liaison updates.

22-0369 Board and Liaison Reports: City of McKinney, MEDC, McDC, McKinney Main Street / MPAC, Visit McKinney Finance Committee

<u>City of McKinney</u> – City Manager Paul Grimes highlighted the upcoming Council Work Session where a range of options will be presented connecting the Downtown Square with the developing Flour Mill District to enhance the pedestrian experience when crossing Highway 5. Grimes gave an update on the current budget process and stood for questions. City Council Liaison Justin Beller had nothing to add.

<u>MEDC</u> – No representatives from MEDC were present. A report is attached.

MCDC – MCDC Board Liaison Deborah Bradford explained the different grant cycles in the attached report: Project Grants, Promotional & Community Event Grants, and Retail Development Infrastructure Grants, and where each of them currently is in the process. Bradford gave an overview of the TUPPS Brewery Expansion Project and stood for questions. City Manager Paul Grimes received clarification from City staff while the meeting went on and explained after the Executive Director's Report that the word "buyout" in the sentence "Buyout of subcontractors/vendors is approximately 90% complete" means "secured" or "under contract."

McKinney Main Street / MPAC – Interim Executive Director Marie Woodard excused McKinney Performing Arts Center/Main Street Program Director Amy Rosenthal's absence and relayed on her behalf Rosenthal's deep appreciation for the partnership amongst everyone regarding the 2022 AT&T Byron Nelson Tournament. Woodard reminded about upcoming May and June events in downtown McKinney.

<u>Visit McKinney Finance Committee</u> – Board member Jon Dell'Antonia covered the operating statement of March 2022, mentioning that Visit McKinney is under budget as of today, and reviewed the STR report with the Occupancy, Average Daily Rate (ADR), and Revenue per Available Room numbers (RevPAR), comparing the numbers with the surrounding cities. Dell'Antonia forecasted that the Hotel Occupancy Tax Revenue for Fiscal Year 2022 might come close to \$2 million.

# **22-0370** Executive Director's Report

Interim Executive Director Marie Woodard thanked the Board, Finance Committee, Nicole Bradshaw in the Finance Department, and Visit McKinney Staff for their help in putting together next year's budget. Woodard reported that both part-time Staff Assistants are trained and highlighted Sales Manager Rachel Tamez and Communications Manager Beth Shumate's accomplishments regarding the Pickleball Tournament and the 2022 AT&T Byron Nelson Tournament. Board member Jon Dell'Antonia thanked Woodard for her transparent budget process. Woodard pointed out the packet each board member received with information on the 2022 AT&T Byron Nelson Tournament and Tamez gave a brief overview how the team comprised of MCDC, Main Street, Marketing and Communications, and Visit McKinney put the branding of the 19th Hole together.
