## **RESOLUTION NO. 2022-07-\_\_\_\_(R)**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN INTERLOCAL AGREEMENT WITH McKINNEY INDEPENDENT SCHOOL DISTRICTS FOR CROSSING GUARDS

- WHEREAS, the Interlocal Cooperation Act, Chapiter 791 of the Texas Government Code, authorizes government entities to contract with each other to perform governmental function sand services under the terms thereof; and
- WHEREAS, the City Council of the City of McKinney, Texas has developed and implemented a School Crossing Guard Program, which the McKinney Independent School District (MISD) would like to use its school campuses located within the City of McKinney; and
- WHEREAS, the City Council of the City of McKinney, Texas agrees to reimburse the McKinney Independent School District (MISD) for certain costs associated with placing school crossing guards at intersections within the City of McKinney which have been designated by the McKinney Engineering Department as needing a crossing guard; and
- WHEREAS, the City Council of the City of McKinney, Texas has before it the proposed Interlocal Agreement between the McKinney Independent School District (MISD) and the City of McKinney, attached hereto, which provided the terms and conditions to provided school crossing guards for the McKinney Independent School District school campuses located within the City of McKinney; and
- WHEREAS, the City Council of the City of McKinney, Texas finds the proposed Interlocal Agreement between the McKinney Independent School District (MISD) and the City of McKinney will promote the Parties' valid governmental interest in protecting the health, safety, and welfare of children traveling to and from school in the region.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas, after review of the terms and conditions of the Interlocal Agreement, hereby approves the attached Interlocal Agreement between the City of McKinney, Texas and McKinney Independent School District (MISD) for Crossing Guards.
- Section 2. The City Council of the City of McKinney, Texas, hereby authorizes the City Manager to execute on behalf of the City of McKinney, Texas the Interlocal Agreement with McKinney Independent School District (MISD) and all other documents in connection therewith.

Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
