## METES AND BOUNDS DESCRIPTION

BEGINNING at a 5/8-inch iron rod found for the northeast corner of said LOT 1R1D, same being on the westerly right-of-way line of U.S. HIGHWAY NO. 75 (a variable width right-of-way);

THENCE along the easterly line of said LOT 1R1D and the westerly right-of-way line of said U.S. HIGHWAY NO. 75 South $04^{\circ} 14^{\prime} 26$ " East, a distance of 165.32 feet to an " $X$ " cut set in concrete at the northeast corner of LOT 1R1C, BLOCK A of ELDORADO PARK ADDITION, an addition to the City of McKinney as recorded in Volume 5967, Page 5850 PRCCT, same being the southeast corner of said LOT 1R1D;

THENCE North $88^{\circ} 05^{\prime} 39^{\prime \prime}$ West, departing the westerly right-of-way line of said U.S. HIGHWAY NO. 75 and along the common line of said LOT 1R1D, BLOCK A and LOT 1R1C, BLOCK A, a distance of 42.28 feet to an "X" cut set for a corner;

THENCE along a curve to the right having a radius of 32.00 feet, chord bearing North $46^{\circ} 59^{\prime} 38^{\prime \prime}$ West, chord length 42.07 feet, through a delta of $82^{\circ} 12^{\prime} 03^{\prime \prime}$ for an arc length of 45.91 feet to an " $X$ " cut set for corner;

THENCE along a curve to the left having a radius of 32.00 feet, chord bearing North $46^{\circ} 59^{\prime} 38^{\prime \prime}$ West, chord length 42.07 feet, through a delta of $82^{\circ} 12^{\prime} 03^{\prime \prime}$ for an arc length of 45.91 feet to an " $X$ " cut set for corner;

THENCE North $88^{\circ} 05^{\prime} 39^{\prime \prime}$ West, a distance of 60.99 feet to an " $X$ " cut set for a corner;
THENCE South $01^{\circ} 53^{\prime} 44^{\prime \prime}$ West, a distance of 29.13 feet to an " $X$ " cut set at the northeast corner of LOT 1R1A, BLOCK A of ELDORADO PARK ADDITION, and addition to the City of McKinney as recorded in Cabinet Q, Page 217 PRCCT.

THENCE in a northerly and westerly direction, along the common line of said LOTS 1R1D and 1R1A, the following:

North $88^{\circ} 06^{\prime} 16^{\prime \prime}$ West, a distance of 235.82 feet to an " $X$ " cut set for a corner;

South $01^{\circ} 53^{\prime} 44$ " West, a distance of 26.30 feet to an " $X$ " cut set for a corner;
North $88^{\circ} 06^{\prime} 16^{\prime \prime}$ West, a distance of 154.97 feet to an " $X$ " cut set for a corner;
North $01^{\circ} 53^{\prime} 44^{\prime \prime}$ East, a distance of 169.64 feet to a $5 / 8$-inch iron rod set for the most north common corner of said LOTS 1R1D and 1R1A;

THENCE South $87^{\circ} 50^{\prime} 37^{\prime \prime}$ East, along the north line of said LOT 1R1D, a distance of 539.78 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 1.861 acres or 81,059 square feet of land more or less.
