#### **CITY COUNCIL REGULAR MEETING**

#### OCTOBER 18, 2022

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, October 18, 2022, at 6:00 p.m. The meeting was broadcast live on cable television Spectrum Channel 16; AT&T U-Verse Channel 99; and online at http://mckinney.legistar.com.

Council Member Geré Feltus commented on recently attending several outstanding local activities: the celebration event honoring Jesse & June McGowen on October 8; the McKinney Chamber of Commerce Young Professionals Beer Stein Challenge – the beer stein designed by Council Member Feltus was the highest bid item, purchased by McKinney Economic Development Chairman Michael Jones – proceeds from the event benefiting the Alliance of Elite Youth Leaders (AEYL) of McKinney; the McKinney Music & Wine Festival; and the Dias de los Muertos event presented by the Legacy Keepers of Old East McKinney. Council Member Feltus thanked the Legacy Keepers for making this year's event better than ever.

Council Member Justin Beller reminded the public about the upcoming Make a Difference Day and opportunities to volunteer with organizations such as Cornerstone Ranch, Embrace Texas, Habit for Humanity, Shiloh Place, Streetside Showers, Community Lifeline, and the old Holy Family School or "la escuelita" as it is known. Council Member Beller commended Beth Bentley and Jason Hernandez of the Legacy

Keepers stating their work, along with the many volunteers and supporters of their organization, is a "gift to their community." Council Member Beller along with several City Staff attended the Bois d'Arc Dam dedication, expressing the significance of the project being the newest dam in Texas in 30 years and McKinney will be the first recipient of water from that lake; congratulated the efforts of the North Texas Municipal Water District (NTMWD) Board, especially the McKinney representatives on the board Joe Joplin (former), Charles McKissick (former), Geralyn Kever (current), and Robert Appolito (current), and the NTMWD employees including David Kelly who is also a member of the McKinney Community Development Corporation. Council Member Beller noted that a dam in his home state of Arkansas is notable for being the final public appearance location of President John F. Kennedy before his fateful trip to Dallas. Council Member Beller also attended the celebration event for Jesse & June McGowen and commended Angela Jackson for organizing the event; attended the groundbreaking event for the Sphinx residential development project located at the corner of Highway 380 and Throckmorton – congratulating the development team as well as Pastor Louis Rosenthal and First Baptist Church on Erwin Street, for utilizing the church's property for the purpose of supporting affordable housing in the community; thanked Deputy Police Chief Jimmy Thomas for escorting him throughout the city during the recent National Night Out event, visiting the Merrit Homes and Chapel Hill communities, although they inadvertently missed the activities at Newsome Homes.

Council Member Rick Franklin reminded the public of the upcoming election on November 8, 2022 with early voting starting on October 24. Several state and national elections will be conducted as well as the city of McKinney ballot item for alcohol sales. Council Member Franklin stated this election is an opportunity for voters to make a difference by keeping a significant amount tax dollars in the city.

Council Member Patrick Cloutier commended Beth Bentley for her help in supporting the Dias de los Muertos event; was unable to attend the McGowen event due to his granddaughter Eleanor suffering respiratory failure for which she was treated at Children's Hospital in Plano. Council Member Cloutier announced she is doing fine now and expressed gratitude toward the McKinney Fire Department and ambulance services for their deep professionalism, kindness and love in managing that experience. Council Member Cloutier stated he will be at the Holy Family School with Council Member Beller for Make a Difference Day, which is located on Lincoln Street. Council Member Patrick Cloutier announced the October 19 birth of his third grandchild Charlotte Underwood, who will be the first child of Cloutier's daughter Madeline. Council Member Cloutier welcomed the prayers of anyone so inclined to offer them.

City Manager Paul Grimes made the following announcement:

- City of McKinney Annual Trick or Treat Trail at the Towne Lake Recreation Area will be Saturday, October 22, starting at 3:00 p.m.; residents of all ages can attend the free event which includes vendors, candy and other treats, costume contest, crafts – live music will start at 7:00 p.m.
- New City Hall Groundbreaking will be Monday, October 24 at 4:00 p.m. at the construction site; free transportation shuttles will be available.
- City Council will not meet for Work Session on Tuesday, October 25. The next City Council meetings will be held on Tuesday, November 1.
- The Bond Committee will meet on Wednesday, October 26, 6:00 p.m. at City Hall Council Chambers.

Mayor Fuller stated the Bond Committee will look at the airport work and plans to date, consider the viability of commercial passenger service, be engaged with the community engagement, and provide recommendations; encouraged the public to learn about the process, be engaged, and visit the city website for updated information.

Council unanimously approved the motion by Mayor Pro Tem Rainey Rogers, seconded by Council Member Charlie Philips, to adjourn the meeting at 7:47 p.m.
