

ORDINANCE NO. 2022-11-____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS TO CHANGE THE 10-MINUTE LOADING ZONE ON LOUISIANA STREET BETWEEN WOOD STREET AND KENTUCKY STREET TO A 20-MINUTE LOADING ZONE AND TO MODIFY THE LOADING ZONES ALONG LOUISIANA STREET IN THE ORDINANCE TO REFLECT ACTUAL FIELD LOCATIONS; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas hereby amends Section 62 – 447 of the Code of Ordinances by adding a subsection to be number 62 – 447 (9), which will read as follows:
- (9) Four spaces on the north side of Louisiana Street beginning 35 feet east of the intersection of Wood Street and Louisiana Street extending 80 feet eastward along Louisiana St to the intersection of Louisiana Street to Kentucky Street.
- Section 2. The City Council of the City of McKinney, Texas hereby repeals Section 62 – 447.1 of the Code of Ordinances
- Section 3. The City Council of the City of McKinney, Texas hereby amends Section 62–447 (3) of the Code of Ordinances to read as follows:
- (3) Three spaces on the south side of Louisiana Street beginning 20 feet east of the intersection of Church Street and Louisiana Street extending 60 feet eastward along Louisiana St.
- Section 4. The City Council of the City of McKinney, Texas hereby amends Section 62–447 (8) of the Code of Ordinances to read as follows:
- (8) One space on the north side of Louisiana Street beginning 60 feet east of the intersection of Tennessee Street and Louisiana Street extending 25 feet eastward along Louisiana St.
- Section 5. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.
- Section 6. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
