

CITY COUNCIL REGULAR MEETING

NOVEMBER 1, 2022

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, November 1, 2022, at 6:00 p.m.

The regular meeting was broadcast live on Spectrum Channel 16; AT&T U-Verse Channel 99; online at <https://mckinney.legistar.com>; and online at <https://mckinneytx.new.swagit.com/views/130>. The video recording of the meeting is available through the City of McKinney meeting archive.

Mayor George C. Fuller called the meeting to order at 6:00 p.m. upon determining a quorum consisting of himself and the following City Council Members were present: Mayor Pro Tem Rainey Rogers, and Council Members Justin Beller, Geré Feltus, Rick Franklin, and Patrick Cloutier. Council Member Charlie Philips joined the meeting at 6:30 p.m. during the Public Comments portion of the meeting.

Mayor Fuller called for Council and Manager Comments.

Council Member Philips extended well wishes to football player Malachi Frazier of McKinney High School who suffered a season-ending leg injury; recognized the McKinney Boys Basketball team for being awarded the 2021-22 state championship after Duncanville High School was ruled disqualified for allowing an ineligible player to participate; praised the McKinney school district leadership for managing its programs the right way; and wished Mayor Fuller an early happy birthday (November 7). Council Member Beller expressed his support for the McKinney teachers, administrators and school system, and expressed condolences to the family and friends of Amanda Kelly; stated he attended the recent Community Health Clinic fundraiser and thanked those who serve others in the community; attended the Make a Difference Day activities organized by Christina Ortega of Volunteer McKinney; attended the Parks & Recreation Trick-or-Treat Trail at Towne Lake that had a very

good attendance; commended City Manager Paul Grimes and city staff on the new city hall ground breaking; stated a recent fire in east McKinney destroyed a church, a home, and a business and encouraged the public to help restore the church especially (New Outreach) as Pastor Eddie Seals has been active in serving the community; and encouraged the public to take opportunity to vote in the current election.
