22-1005 Minutes of the Visit McKinney Board Meeting of September 27, 2022

Board members unanimously approved the motion by Board member Katie Scott, seconded by Board member Deidre Woodard, to approve and refer the minutes of the Visit McKinney Board Meeting of September 27, 2022, to City Council.

REPORTS

Board Chair Connie Gibson called for Board and Liaison updates.

22-1006 Board and Liaison Reports: City of McKinney, MEDC, MCDC, McKinney Main Street / MPAC, Visit McKinney Finance Committee

<u>City of McKinney</u> – City Council Liaisons Richard Franklin and Justin Beller had no updates. Assistant City Manager Steve Tilton mentioned the recent groundbreaking ceremony for the new City Hall and gave an update on the Airport Bond Committee that has its second meeting coming up. Franklin gave more information on what members make up the Airport Bond Committee and Beller explained the City's Proposition A on the ballot for the upcoming election in November. Executive Director Aaron Werner asked if the Visit McKinney Board can get a more in-depth update on the future of the airport and Tilton affirmed that this would be arranged.

MEDC – No representatives from MEDC were present. A report is attached.

<u>MCDC</u> – MCDC Board Liaison Deborah Bradford explained the different grant cycles in the attached report: Project Grants, Promotional & Community Event Grants, and Retail Development Infrastructure Grants, and where each of them currently is in the process. Bradford gave an overview of the TUPPS Brewery Expansion Project and the status of the TUPPS incubator initiative called "Build Your Own Business", announcing a soft opening in December and a Grand Opening in early Spring.

<u>McKinney Main Street / MPAC</u> – Interim MPAC/Main Street Program Director Andrew Jones reviewed past events and listed upcoming dates for November and December, with a special focus on this year's "Home for the Holidays" festival.

<u>Visit McKinney Finance Committee</u> – Executive Director Aaron Werner explained the substantial surplus left in the budget due to cautionary spending during the transition to the new Executive Director, the record Hotel Occupancy Tax collection last fiscal year, and how weekend versus weekday travel patterns looked like. Werner covered the operating statement of September 2022 and reviewed the STR report with the Occupancy, Average Daily Rate (ADR), and Revenue per Available Room numbers (RevPAR), comparing the numbers with the surrounding and similar cities. Werner stood for questions regarding the surplus from last budget year and consideration of other comparative cities.

REPORTS

22-1010 Executive Director's Report

Executive Director Aaron Werner welcomed all new Board members and asked Alternate Board member Jon Christopher Davis to give a brief bio. Werner explained the Texas Music Friendly designation the City of McKinney holds, the recent bylaw changes, and his vision where Visit McKinney needs to head towards in regards to tourism. Werner detailed the recent corporate hotel booking losses, talked about what kind of hotels are needed in the future, and how the partnerships with other City entities, like MEDC, will help get us there. Werner highlighted several sales data points, presented various recent marketing campaigns, and gave an update regarding the Visitor Center remodel, the architect firm that was retained, and the new furniture coming from MEDC. Werner gave shoutouts to Executive Assistant Sabine Smith, who graduated from the City's 3-day HPO course, and Communication Manager Beth Shumate, who celebrates her 15-year work anniversary in November. Shumate gave an overview a TV project she is working on with the Dallas Film & Creative Industries Office and a film production scout in the hopes of attracting the production to McKinney. Werner lauded Sales Manager Marie Woodard's sales efforts and explained the hiring process for the new Meeting & Event Services position and how everyone participated, including the two staff assistants Amy Bertino and Sarah Wilson. An offer to the best candidate has been extended. Board member Whitney Nash, who was involved in the Executive Director's hiring process, expressed her gratitude that Werner does apply the collaborative traits that they were looking for. Shumate highlighted a recent positive google review the Visitors Bureau has received due to the kind and caring actions of the Staff Assistants Bertino and Wilson.

Board member Deidre Woodard introduced her guest Melissa Cantu who plans to apply for a grant in the next grant cycle. Cantu briefly gave an overview of her business.
