	It is an honor to nominate Pat Rodgers for the MCDC 2023 Quality of Life Award. Pat has lived in McKinney for 57 years. She wasn't born here, but as the saying goes, she got here as quickly as she could. She raised her family here, was a Speech

Therapist and Principal in McKinney ISD and has been active in her church and a vital part of the community.

When Pat moved into her home on Lamar Street in the historical district, her love of the history of the City of McKinney began to grow. In 2006, her 1910 historic home was on the Christmas Tour of Homes and she greeted over 1600 visitors into her home that weekend. She soon joined the Board of Directors at Chestnut Square where she served as board president for three years. She served as the Director for the Christmas Tour of Homes for 10 years, interviewing the home owners, selecting the head docent for each home, and training the volunteers. The tour was a huge success over her time of service, bringing thousands of people to McKinney.

Pat also wrote the scripts and developed trolley tours through the historic district. She rode the trolley each Saturday morning narrating the story of how McKinney began and pointing out beautiful Victorian homes and the stories behind each one. She recently developed a new trolley tour called, The Bad Boys, Desperados, Outlaws and the Petticoat Terror of Collin County. It has attracted many visiting tour groups and convention attendees. The story is very entertaining and often requested. She dresses as Belle Starr and tells her story as well as the stories of Frank and Jesse James, Cole Younger, Sam Bass and other infamous characters. The trolley travels through McKinney and visits the spots made famous by these outlaws.

She currently serves on the Board of Directors for the Collin County History Museum and has helped lead tours of the historic 1911 Post Office building. Pat has developed programs for schools and community organizations. She helped create the past four exhibits that have attracted thousands of people to the historic downtown: 250th Birthday Celebration of the Life of Collin McKinney, McKinney Christmas Past, Collin County WWI Centennial Commemoration, and McKinney Then and Now. She is currently working on the new exhibit Created in Collin County.

During COVID when all tours stopped and the museum was closed, Pat did not let that stop her from sharing her stories. With the help of her husband Charles, she turned a room in her house into a production studio. She rewrote all of her programs and hosted ZOOM presentations hosted by the museum and Celebration Magazine. The programs were a hit as hundreds of people from Dallas, Denton, Collin, Tarrant and Hunt Counties joined online to hear and see her presentations. She dressed in period costume and had a green screen background, and showcased hundreds of historic photos of downtown McKinney during her programs.

Currently she writes historical articles in Celebration Magazine promoting the City of McKinney and was spotlighted on the cover of the 2022 July issue. Her articles have launched her YouTube career. She includes a QR code in each article that is linked to videos that have been a huge success with over 32,000 visitors to her YouTube channel.

Pat's love of history and McKinney is contagious. She is tireless in her efforts and dedication to telling her stories. She is an inspiration to all the people that she meets. Thank you for considering Pat Rodgers as the 2023 recipient of the MCDC Quality of Life Award.

EMBRACE WAITING CHILDREN

It is with great pleasure that I nominate Embrace Waiting Children, Inc. for the 2023 Quality of Life Award. This organization exemplifies "quality of life" for so many reasons, for so many in McKinney and in surrounding areas.

In 2006 a handful of passionate volunteers in McKinney began the work of identifying the needs of vulnerable children who were unable to advocate for themselves. They did this because they had noticed a lack of local services available to families who were fostering. The team developed a plan to improve outcomes for neglected and abused children by recruiting highly engaged foster and adoptive families, and strategies to support and encourage those families who had already committed to meeting this critical need. They rallied volunteers to provide practical items for children and deliver meals to families, and support groups were established to provide valuable training and fellowship to families opening their homes to care for kids.

As the group interacted with more families, new needs were uncovered. Services were expanded to include respite care nights, accessible family events, and parent training retreats. By partnering with Child Protective Services, and local child placing agencies, they were able to host informational meetings and foster parent training. The team began to positively impact not only the quantity of foster parents in Collin County, but the health and retention rates for these families as well.

The mission and scope of the needed services quickly outgrew the capacity of its dedicated volunteers. With the support of the ministry's Board, co-founders Denise and Bruce Kendrick took the leap to become the first full-time staff members in 2010. The organization was then formally recognized as a 501(c)(3) nonprofit organization, **"Embrace Waiting Children, Inc.**"!! A modest office space of only 600 square feet, on the square in downtown McKinney, was leased by Embrace and the first "headquarters" were officially opened.

In 2014, Embrace secured a unique Memorandum of Understanding with Child Protective Services to become an advocate for children lingering in foster care, waiting for adoption. This collaborative effort united congregations from McKinney and surrounding cities with the goal of a home and family for every child in Collin County. *Child to Family Connection* events brought together caseworkers and prospective adoptive parents to find possible adoption "matches" for waiting children. Children and teens represented through this groundbreaking effort spend less time languishing without permanency and are less likely to "age-out" of foster care. In 2015 and 2016 members of the Embrace staff were honored as *Angels in Adoption* by the Congressional Coalition on Adoption Institute in Washington, DC by Congressman Sam Johnson. The Embrace Church Network was launched in 2016 to provide a platform to connect churches, community groups, and volunteers with the needs of local children and families.

And then... the pandemic. Embrace (like many nonprofits) was forced to pivot. They went from longstanding ways of providing successful "in-person" support and training to families, to offering virtual options, on the turn of a dime. The staff swung into action and

quickly converted monthly support groups, workshops and even the Child to Family connection events to virtual platforms. During this volatile and uncertain time, a larger office space became available on the opposite corner of East Louisiana. Embrace jumped at the chance to expand their outgrown office space, while still maintaining a close proximity to CASA and other partner McKinney organizations. The new office opened in June of 2020, and in addition to larger operations space, there was storage for household items for youth aging out of foster care. As a proud community partner and one who recognized the importance of the work they were doing, RBFCU contributed funds (along with many other local organizations) to help outfit an area to be suitable for visitation space. This would be used for siblings who were placed in separate foster homes to come together for games, meals, and fellowship— to maintain those critical sibling relationships. Again, Embrace staying aware of the needs, realized other venues (for such visits) were closed due to the pandemic, jumped right in to fill this critical need in McKinney. A pandemic wasn't going to stop them!!

In the spring of 2021, Embrace became aware of another developing crisis in the foster care system in Texas. Rising concerns for the quality of care being provided in children's homes caused many of the group homes to shut down. Hundreds of children were instantly displaced. These children, and more entering foster care daily, were shuffled to CPS offices, makeshift shelters, and hotels—many in McKinney and surrounding areas. Children's negative behaviors began escalating almost immediately in this setting. As this crisis reached the boiling point, Embrace stepped in to provide meals, welcome bags, and volunteers—all focused on mitigating the negative consequences of the less-than-ideal living situations.

In the following months, it became apparent that housing children in these types of sterile environments did not promote healing, and instead exacerbated existing behavioral/emotional challenges. These significant shifts in housing had created a major, long-term gap in services to foster children. As no other solution seemed available, the Embrace staff embarked on an urgent mission to advocate for healthier, more caring environment for these vulnerable children stuck in limbo. As if sent from someone above... Embrace identified and secured a suitable property that could provide a safe, temporary home for children without placement. "**Collin House**", a historic home near downtown McKinney, (with a beautiful pink door) was purchased and began welcoming children in June of 2022. A spacious yard allows for healthy recreation. As opposed to the frozen and fast-foods the children consumed in hotel settings, they now have a full kitchen and cheery dining room offering healthy, familiar home-cooked meals served each evening by volunteers. And, on top of all that, the Embrace headquarters was also able to be relocated onsite, in a separate building, which negated the need for leased office space.

Depending on the unique needs of children and sibling groups served, Collin House can accommodate 40 children, per year, for overnight stays, and an additional 70 per year for day use. This temporary stopover gives children a safe, comfortable place to grieve and heal, and is part of keeping more sibling groups together. A community of support is built around the children, as volunteers from McKinney and the local community commit

to be a part of the Collin House "family". The volunteers tutor, prepare meals, host holiday and seasonal celebrations, and teach arts/crafts workshops.

In 2022 more than 630 individual children benefitted from services such as family campouts, respite events, movie night and sports outings, as well as support and retention services offered to their caregivers. Embrace continues to innovate foster care and adoption ministry efforts by incubating programs in Collin County and multiplying those efforts to other areas of Texas and the rest of the country.

I know there are many organizations worthy of this award, but this one is near and dear to my heart because of who they are, and what they are doing for so many. I have personally, and on behalf of RBFCU, volunteered for events that they put on for the children, foster parents and CPS workers. They bring so much joy and support to so many! It is because of the dedication, the determination, and the love the staff has for what they are doing, that thousands of children are literally saved from crisis. I have witnessed it first-hand. Embrace Waiting Children, Inc. has an impact that goes far beyond the families and children they serve. They have impacted me in so many ways that I wholeheartedly believe they are worthy of and should be the recipient this awesome award!
